FY 21 4th QUARTER ACTIVITIES

- Discussed how to deal with public comments not pertaining to the agenda and the timeline/roadmap to complete the mapping process. Received a summary of the *Brnovich vs. Democratic National Committee* decision issued by the U.S. Supreme Court.
- Held a public hearing in Grand Rapids and heard 118 public comments for four hours and thirty minutes.
- Demonstration between the CityGate software for desktops and the Web-based software. Presentation on the trends in public comments and Communities of Interest coverage maps. Presentation of the Philosophical Discussion on Redistricting. Presentation on Implicit Bias.
- Presentation on The Law of Redistricting, DOJ, and Cautionary Tales. Presentation on Measures of Partisan Fairness. Discussed irregularly shaped districts and its rationale, gerrymandering, transparency, data sets, and automated redistricting.
- Approved to accept as standard procedure the Assuring Quoroms and Notifications of Absences Memo as policy by identifying where the policy begins and striking the header about eligibility to attend remotely. Approved financial procedures. Approved receiving and filing emergency procurement documentation for Audio Visual for July 8, 9, and 15.
- Presentation on utilization of computer algorithms in mapping.



- Discussion on identifying geographical regions within Michigan to begin mapping.
- Approved paid time off for staff. Approved revisions to the budget. Approved media buys to increase awareness and engagement. Discussed geographic regions to begin mapping. Identified 9-10 regions for mapping.

Reviewed the collaborative and the Commissioner's Congressional maps to ensure compliance with the Voting Rights Act. Reviewed State Senate maps for compliance with the Voting Rights Act. Mapped State House districts, primarily in the Metro Detroit region. Expand the line drawing contract to include



assessments for partisan fairness and voting patterns. Approved the Covid-19 self-assessment.
