3. General Counsel Candidate Discussion. Commissioner Clark, chair of the Advisory Committee Reviewing General Counsel Candidates, shared the process behind the committee's recommendation of two General Counsel candidates from the pool of ten applicants to be interviewed by the full commission. Vice Chair Kellom led the commission's discussion of the advisory committee's recommended candidates as well as other applicants.
