- Discussed the draft Commission report. Accepted the May financial report. Approved the FY 22 Revised Budget. Presented the FY 23 Draft Budget. Ratified the contract with Insights3 to provide accounting and financial reporting services. Approved Sept. 29 as the only meeting date in September.
- Approved the Commission Report. Discussed the Dormancy and Reactivation Plan. Adopted the MICRC FY 23 Budget that has 13 Commissioners' salaries at 25 percent of the Governor's salary but does not have the provision about attendance being required at meetings to be paid. Revised the meeting dates to Oct. 27 for October and Dec. 15 for December. Approved the Election Data Services addendum for Expert Witness Support for Pending Litigation. Accepted the June and July financial reports. Approved the minutes for June 9 and July 21.
- Approved the Lessons Learned Report and Recommendations. Approved the change order to increase the contract values for Baker Hostetler (\$2 million), Fink Bressack (\$500,000), Election Data Services (\$500,000), and the VRA Legal Counsel (\$150,000) until the next Commission is seated either on or before Oct. 15, 2030. Accepted the August financial report. Adopted the FY 22 Revised Budget. Adopted the FY 23 Budget. Approved an animus brief for the Arizona Redistricting Commission. Approved the contract for MICRC Part-time Executive Director. Elected Commissioner Dustin Witjes as chairperson and Commissioner Douglas J. Clark, Jr. as vice-chairperson.
