Acting Chairperson Steve Lett called for a roll call vote on the original motion by Commissioner Clark to <u>instate institute</u> a 6-month semi-permanent chairperson structure in which the commission chairperson and structure would be re-assessed exactly six months from the day of the vote (i.e. March 18, 2020). 2. CHAIRPERSON SELECTION

Acting Chairperson Lett requested nominations.

MOTION: Keep Acting Chairperson Lett as the chairperson for the initial six (6) month term. **Motion by Commissioner Witjes**. **Supported by Commissioner Vallette.** Acting Chair Lett accepted the nomination.

MOTION: Nominate Commissioner Kellom as the chairperson for the initial six (6) month term. **Motion by Commissioner Rothhorn. Supported by Commissioner Eid.** Commissioner Kellom accepted the nomination.

3. VICE-CHAIRPERSON SELECTION

Chairperson Lett requested nominations.

MOTION: Nominate Commissioner Kellom as the vice-chairperson for the initial six (6) month term. **Motion by Chairperson Lett. Supported by Commissioner Eid.** Commissioner Kellom accepted the nomination.

MOTION: Nominate Commissioner Eid as the vice-chairperson for the initial six (6) month term. **Motion by Commissioner Eid. There was no second.**

MDOS staff called roll for the vote of each commissioner. BRITTNI KELLOM WAS ELECTED VICE-CHAIRPERSON 9-4. Each commissioner voted as follows:

4. HIRING STAFF

The commissioners discussed possible staffing needs and options. They also discussed the role of the Secretary of State's Office in keeping minutes for the meeting.

MOTION: Hire an executive director for the commission. Motion by Commissioner Witjes. Supported by Commissioner Clark. Chairperson Lett held a voice vote. MOTION UNANIMOUSLY APPROVED.

MOTION: Request that MDOS staff prepare a draft job descriptions and postings for the commission's review. Motion by Commissioner Orton. Supported by Commissioner Decker. Chairperson Lett held a vote by show of hands. MOTION UNANIMOUSLY APPROVED.

MOTION: Request that MDOS staff work with the Legislative Council to provide the commission with government email addresses. Motion by Commissioner Orton. Supported by Commissioner Witjes. Chairperson Lett held a vote by show of hands. MOTION UNANIMOUSLY APPROVED.

Chairperson Lett asked that MDOS staff bring the following draft job descriptions, postings and materials to the commission for review: draft request for proposal; executive director; racially-polarized voting consultant; outreach director; in-house legal counsel.

5. BUDGET AND COMPENSATION

The commissioners discussed compensation, frequency, reimbursement of costs, overall budget allocations, and timing of the budget.

MDOS staff clarified that the constitution sets forth that payment received by commissioners is "compensation", and that the constitution does *not* refer to commissioner payment as a "salary." MDOS staff clarified **that** that if the commission elects to receive monthly payments for 12 months equal to 25% of the Governor's salary, that after 12-months, the total compensation required by the constitution for each commissioner will have been exhausted.

Michigan Department of State staff again clarified the language of the Constitution regarding Commissioner payment and compensation. MDOS staff stated that payment received by Commissioners is regarded as compensation, not as salary, and is currently only limited to a set compensation of 25% of the Governor's annual salary.

MOTION: That each commissioner be paid 25% of the Governor's monthly salary on a monthly basis. Motion by Commissioner Clark. Supported by Commissioner Curry. Discussion ensued.

MOTION TO AMEND: That each commissioner be paid on a bi-weekly basis 25% of the Governor's bi-weekly salary.

Motion by Vice-Chairperson Kellom. Supported by Commissioner Witjes. Discussion ensued.

SUBSTITUTE MOTION: Request that MDOS staff collect further information from the Legislative Council on instituting bi-weekly or monthly payments. Motion by Commissioner Witjes. Supported by Commissioner Clark. Chairperson Lett held a voice vote. MOTION UNANIMOUSLY APPROVED.

6. FUTURE MEETINGS

The commissioners discussed general availability and schedules. They also discussed, and MDOS staff clarified the requirements of the Open Meetings Act, including the advance notice timing needed for subsequent meetings. The Commission requested that MDOS staff collect long-term availability from each commissioner and provide it to the commission to determine dates and times for recurring meetings.

MOTION: Request that MDOS staff collect long-term availability from each commissioner and provide it to the commission to determine dates and times for recurring meetings. Motion by Chairperson Lett. There was no second.

MOTION: Designate Friday, September 25, 2020 as the day of their next meeting. Motion by Commissioner Orton. Supported by Vice-Chairperson Kellom. Chairperson Lett held a voice vote. MOTION UNANIMOUSLY APPROVED.

PUBLIC COMMENT

Chairperson Lett opened the floor to public comment.
