In the discussion on August 6 about fairness measures, the issue of proportionality was raised. Dr. Handley correctly said that the courts do not require redistricting bodies to produce proportional outcomes. Commissioner Rothhorn pointed out that the public comments indicate that people want proportionality, and asked if the Commission had to choose. I think that is a false choice. The courts do

not say that redistricting bodies should NOT address proportionality; they only say that proportionality is not a criterion that can be used in a challenge (unless as DR, Handley pointed out it is so egregious that it smells of gerrymandering).

So I would encourage the Commission to check their results for proportionality as they draw. This may not be possible region by region but will be possible when the entire plan is made. They can compare plans using past results to say whether their new districts would or would not produce a more proportional result.

I suggest this be built into the software to make this an easy last step.

Re: Selection of Legal Counsel

Dear Members of the Michigan Independent Citizens Redistricting Commission:

We write on behalf of the ACLU of Michigan to express our grave concern with the current state of the Commission's selection process of a law firm to advise and represent it. Specifically, we understand that in response to its RFP, it has thus far only accepted a submission from Baker & Hostetler LLP ("Baker"). Selecting this law firm, however, would contradict the independent nature of the Commission and its goal to produce fair maps for all Michiganders given Baker's extensive history of defending some of the most egregious partisan and racial gerrymanders of recent years. While a complete lack of previous political representation may or may not be feasible, selecting a law firm so inextricably intertwined with partisan redistricting practices will undermine the entire redistricting process in appearance if not effect. We therefore urge the Commission to allow time for additional applications and ultimately to choose a law firm without a history of defending and supporting extreme partisan and racial gerrymanders.

The Baker RFP provides evidence of many cases in which it has defended redistricting plans that courts held are unconstitutional partisan or racial gerrymanders. For example, the RFP lists Baker's work defending Pennsylvania's 2011 congressional redistricting plan. Yet the Pennsylvania Supreme Court held that the plan it defended "clearly, plainly and palpably violates the Pennsylvania Constitution" because the plan was a "partisan gerrymander" that "was extreme and durable" and "designed to dilute the votes of those who in prior elections voted for the party not in power in order to give the party in power a lasting electoral advantage." It found this plan was "aimed at achieving unfair partisan gain" and therefore "undermine[d] voters' ability to exercise their right to vote in free and 'equal' elections."

Baker also touts its representation of ten members of Ohio's congressional delegation in defending Ohio's 2011 congressional redistricting plan against a partisan gerrymandering claim. A three-judge federal court, however, found that the "map drawers' controlling intent was to lock in a 12-4 map in favor of Republicans, that goal was accomplished, and no other causes or justifications

explain" the map's "extreme partisan effects." As such, the court held that the map Baker defended was a partisan gerrymander that "was intentional and effective and that no legitimate justification account[ed] for its extremity." Additionally, the court noted that one of the Baker attorneys listed on the RFP "was retained by the Ohio Attorney General to represent and advise the General Assembly during the 2011 redistricting process," and that he "advised them and collaborated with [Republican staffers] during the map-drawing process." Thus, Baker attorneys not only defended the extreme partisan gerrymander, but at least one provided advice to those who crafted it. Although this decision was ultimately vacated because the U.S. Supreme Court held that partisan gerrymandering claims were not justiciable in federal courts because they implicate the political-question doctrine, the Supreme Court did "not condone excessive partisan gerrymandering" or undermine the merits of the three-judge court's finding in Ohio or elsewhere.

Baker's defense of redistricting plans also includes Virginia's unconstitutional racial gerrymandering of a number of State House of Delegates districts. In that case, a federal court held that Virginia "sorted voters into districts based on the color of their skin" in a manner that was not justified by the Voting Rights Act and thus violated the Constitution's equal protection clause. ⁹ The United States Supreme Court dismissed an appeal, leaving the ruling in place. ¹⁰

The ACLU of Michigan understands the time-sensitive nature of the redistricting process. Yet selecting a law firm whose recent history includes the defense of multiple extreme gerrymanders and even involvement in at least one state's drawing of such maps runs contrary to the goals of the Michigan Constitution and will undermine public confidence in the process. We urge the Commission to allow for additional submissions and to select a law firm without an extensive recent history of defending partisan gerrymanders.



Thank you so much for your time and service which I so greatly appreciate.



NOW, THEREFORE, BE IT RESOLVED BY THE TOWNSHIP BOARD OF THE CHARTER TOWNSHIP OF DELHI, INGHAM COUNTY, MICHIGAN, That the members of the Delhi Township Board urge the Independent Citizens Redistricting Commission to keep Delhi Township intact and within Ingham County and the Lansing Region when drawing district lines for the 2022 election and beyond.
