Below are my public comments I shared at the Gaylord afternoon public hearing. Thank you for your time and effort on this project.

My name is Jane Scott and I am a 32 year resident of the city of Midland. The lines between the city and county of Midland are blurred as we act as one community. The county fairgrounds are in the city and city residents often frequent Sanford Lake (before the flood) and my family and many others have used the surrounding county community centers for basketball practice. I have lived through many flood events in my time in Midland but never anything like the night of Tuesday May 19, 2020. That night several families evacuated to my home and we all waited to see where the water from the failed dams would go. Wixom, Secord, Smallwood and Sanford lakes all were flowing toward the city of Midland during a 100 year rain event. The devastation was overwhelming. My home was spared but countless homes and businesses in the city and county of Midland were washed away or damaged. Although we were in the middle of a pandemic, the community support to volunteer throughout the watershed was a beautiful sight to see. I volunteered in Sanford and stood side by side with other watershed neighbors trying to salvage what we could. The watershed does not care what political lines you draw, it will go where it wants. We need a united Midland and Gladwin county to work on this huge process to make us whole again. Grouping us with Bay City, Saginaw and Flint will complicate these efforts and are unfair to the residents of the watershed. Please do the right thing and keep Midland county whole and with our watershed neighbors.

I support Lange Congressional map #243, Lange State Senate map #247 and Oak State House map.

Good Afternoon Commissioners,

I speak to you today as an individual member of the Midland County Board of Commissioners (BOC). In addition to our essential services and pandemic protocols, our BOC mission has expanded to include recovery from the dam failures in May 2020.

In Lansing, our current Leadership has been able to advocate for more than \$200 million in funds to help rebuild the four dams along the Tittabawassee River, as well as resources for flood mitigation. In Washington DC, as a unified county, the Midland community has benefited from a federal disaster declaration and more than \$100 in direct disaster assistance.

Unfortunately, your efforts threaten to undermine how far we have come as a community. The city of Midland has been sliced and diced and separated completely from the rest of the county in most all your illustrations.

I advocate for the following: State House, State Senate and US Congressional maps that keep Midland County intact with the City of Midland, as well as keep Midland County with Gladwin County. Please reject any map that removes the city of Midland from the rest of the county.

Thank you for hearing my comments regarding redistricting and the way that Midland has been carved out of the remainder of the proposed new districting that will have a major impact on my community of Beaverton and Gladwin County as a whole.

Gladwin County has long been tied to Midland County at the congressional, and statewide level and for decades we have worked together with our neighbors on economic, social and environmental issues that tie our communities together. As a previous City Manager and Mayor and current DDA Chair in the City of Beaverton, I believe the proposed map and implications will have a devastating effect on the work that myself and so many others have worked on over time.

Major negative implications could result from gerrymandering Midland County on our efforts surrounding our watershed. I live on the very river that was impacted by the recent flooding that affected my community and Midland. Most recently I worked on grants to help shore up the Beaverton Dam and surrounding watershed issues in an attempt to repair the immediate damages and salvage a significant part of our economy.

This and other regional work has never lead me to Flint or Saginaw for help and partnership, but back to Midland and our true partners with whom we've worked over the decades. None during that time may have been as critical or remains as critical to my community as the loss of income and tax base due to flooding.

Our goal is simple, rebuild and recover with an eye toward conservation and the environment. We need to continue that effort with the same partners who were there from the beginning and are equally impacted. I urge you not to gerrymander Midland leaving our community directly to the north negatively impacted by the results.
