Hispanics and Health Care Coverage



Hispanic Heritage Month is celebrated from September 15th to October 15th. The U.S. Department of Health and Human Services Office of Minority Health describes Hispanics as any person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture or origin, regardless of race. There are 62.1 million Hispanics in the U.S. Hispanics are


the largest minority population—18 percent of the total U.S. population.

Hispanics have the highest uninsured rate of any racial or ethnic group in the U.S. Almost 19 percent of Hispanics are uninsured. The lack of health insurance and preventative care contributes to Hispanics developing chronic conditions such as cancer, cardiovascular disease, diabetes, and obesity. The leading causes of illness and death among Hispanics are heart disease, cancer, accidents, stroke, and diabetes. The high cost of an employer-sponsored health plan and an employer not offering health care coverage are among the reasons that Hispanics are not insured.

Communication and language barriers are associated with decreased quality of care and poorer health outcomes. Individuals with limited English proficiency are less likely to have routine health visits, more likely to defer needed health care, and more likely to leave the hospital against medical advice.

Thank you all to our MIHP agencies that serve this population and continue their commitment to improving their health and wellbeing. The Boppy Company recalls over 3 million Original Newborn Loungers, Boppy Preferred Newborn Loungers and Pottery Barn Kids Boppy Newborn Loungers after 8 infant deaths.
