

Billing Guidance – FY 2022

Healthy Moms Healthy Babies MIHP Enhanced Services Pilot -*High Risk Beneficiaries*

Important Considerations:

- HMHB Pilot-only services are to be billed to Medicaid FFS through CHAMPS, not to the Medicaid Health Plans (MHPs). Continue to bill “standard” MIHP services to the client’s MHP.
- Claims for MIHP pilot-only services must be submitted on a separate claim from other MIHP services.
- All claims require a primary diagnosis code for an infant-related or pregnancy-related condition and the diagnosis code must be included in the first or primary position on professional claims.
- Beneficiaries enrolled in Integrated Care Organizations (ICOs) through MI Health Link, are NOT eligible to receive pilot services. MI Health Link beneficiaries can be identified by reviewing their assigned benefit plan, which shows as ICO-MC.
- HMHB Pilot codes are only to be used by participating agencies during the pilot period. MIHP agencies in the treatment group can bill all pilot services. MIHP agencies in the control group can bill the pilot discharge visit only.
- Please be sure to use the most recent HMHB MIHP Pilot billing guidance as guidance is subject to change.

*Denotes services which may be billed via telemedicine - report with modifier GT and POS 02.

*Additional Home Visit	H1001	One-time additional face-to-face professional visit.	Billed by test agencies at any time during the program for a single beneficiary. Limit of 1 per beneficiary per MIHP enrollment.	\$92.09
*Complex Home Visit With Additional Face-to-Face Time	99600	Single code for all face-to-face services provided in a single day. To be reported for visits lasting more than 59 minutes in length.	Test agencies report for a visit lasting 60 minutes or more. Bill in place of normal visit 99402. *For visits lasting 30-59 minutes report 99402 and submit claim to MHP.	\$138.14

Enhanced Care Coordination Time	T2022	Report for provider office-based phone calls, referrals, and non-face-to-face time. Report when at least 30 minutes of MIHP home visitor time is spent in care management activities during a calendar month.	Limit of 1 per calendar month per beneficiary per MIHP enrollment. Claims must include 1 pregnancy-related or 1 infant-related diagnosis code, along with all relevant ICD-10-CM Z-code(s) representing the social determinants of health addressed through the enhanced care coordination service.	\$77.06
*Discharge Visit	H1004	Do not report if the only activity is sharing the survey - a visit must be completed. Minimum time face-to-face with beneficiary 30 minutes.	Limit of 1 per year per beneficiary per MIHP enrollment.	\$108.89
