#### CARECONNECT 360 OVERVIEW

#### CareConnect 360

- Care management portal
- Will replace the existing MIHP application (MILogin)

#### MIHP - CC360 Integration:

- Centralize all program records and administrative documentation in an electronic format
- Streamline program administration
- Support partner collaboration and communication
- Expand data collection and integration with statewide databases
- Ability to generate agency-specific reports

#### TRAINING OUTLINE

#### Schedule is being finalized

#### Training will include CC360 use and applicable program guidance

- Hosted by CC360 Training Specialist & MDHHS MIHP
- Weekly sessions beginning in early 2023
  - Six core sessions, including a Refresher
  - Dedicated time for feedback
  - A "Go-Live" date will be determined
- Routine drop-in sessions for continued support
- As new functionality becomes available in CC360, a training will be added

#### TRAINING OUTLINE, CONT'D

- Agency's responsibility to assure staff can perform program functions in CC360

- Registration links to choose preferred session and add to calendar





#### PILOT FUNCTIONALITY

#### Risk Identifier

 Redesign of the Health Assessment is underway and will be integrated into CC360

#### Discharge Summary

#### Professional Visit Progress Note

- Maternal, Infant, and Lactation
  - During the pilot, MIHP agencies who use an EMR may choose to use current EMR system or CC360 for progress note documentation

#### Beneficiary Record Transfer

Personnel Roster Management

#### Form Export

#### GENERAL CONSIDERATIONS

- Agency-wide transition
  - Suspend use of MIHP Application and use CC360 for all available functionality
- All MIHP users will have the same access to CC360
  - All staff will be offered training and have access to all functionality
  - Only professional staff will be allowed to complete and sign PVPNs
- Bill in accordance with agency process
  - CC360 current functionality will not include direct billing
- CC360 Pilot Program Guidance will be provided
  - Example: Transfer Management

## Manual upload to existing EMR or third-party billing system will be required

- Similar to current process for Risk Identifier in MIHP Application
- Download of Risk Identifier, PVPNs, and Discharge Summary to PDF will be available

MDHHS MIHP met with EMR vendors in September to begin conversations about bi-directional communication

BILLING CONSIDERATIONS AND EXPORT FUNCTIONALITY

#### EMR VENDOR AND MEDICAID HEALTH PLAN COLLABORATION

- The following EMR vendors have attended a demo session about CC360
  - MIHP EMR
  - eClinical
  - Patagonia
  - Epic
- Early 2023: Additional session with EMR vendors anticipated
  - Focus on bi-directional progress note
- October: MDHHS MIHP discussed Medicaid Health Plan integration
  - Template design in-progress for interactive referral system priority functionality for early 2023

Reviewers will be trained in CC360 and will review chart in agency system and CC360 Export
functionality will

Participating in the pilot will not negatively impact certification review No certification reviews for pilot agencies until fall 2023

### MIHP APPLICATION DATA TRANSFER TO CC360

- All beneficiaries enrolled after a "Go Live" date will be enrolled via CC360
- Open cases will also be transferred
  - Completed Risk Identifiers with no Discharge Summary will be uploaded to CC360
    - Future PVPNs and Discharge Summary will be entered in CC360
- Guidance and timeline will be provided

# POSSIBLE ENHANCEMENTS

- For consideration after statewide integration
  - Scheduling
  - Alerts for certain deadlines or requirements
  - Direct billing

# PILOT PROVIDER PREPARATION

- MILogin access is necessary for training purposes
  - Current staff without MILogin user ID
    - Gain access by Jan 1, 2023
  - New staff hired prior to Go-Live date
    - Submit MILogin user IDs
- Submit new MiLogin IDs to MDHHS-MIHP-Advisory@michigan.gov

#### CC360 TRANSITION SUMMARY

Training Outline will be provided soon

CC360 Pilot Functionality – Mirrors MIHP Application

 Processes will largely remain the same – shifting data entry from MIHP Application to CC360

MDHHS MIHP is working with EMRs and MHPs directly to support the transition
