# Infant Safe Sleep Month/SIDS Awareness Month

In recognition of October as Infant Safe Sleep Awareness Month and SIDS Awareness Month, the following resources are available to share with your families:

#### **Required MIHP Training Update**

Effective November 1, 2020, all newly hired staff must follow the completion guidelines for training:

- Waiver staff are required to complete their training within sixty days and prior to any individual face-to-face visits being conducted.
- New and Backup staff (those not requiring a waiver) are required to complete their training within thirty days and prior to any individual face-toface visits being conducted.
- Other staff listed on the personnel roster should complete their required training within two weeks and prior to working with beneficiaries (answering phones, corresponding via email, etc.).

The above timeline applies to all staff on the personnel roster hired on or after November 1, 2020. Completion forms will be updated and available by that date.

### Michigan's Safe Delivery Program



The Safe Delivery law allows a parent or parents to safely and legally surrender their newborn of no more than 3 days old. A newborn may be given to a uniformed employee who is inside and on duty at any hospital, fire department, police station, or to an emergency medical technician or paramedic by calling 9-1-1. The newborn will be placed for adoption.
