MIHP Services Exception Requests

This information was provided in an MIHP weekly update last June, however with the pandemic struggles last year and new agency home visitors this reminder may be helpful.

In limited situations, when beneficiary needs surpass outlined MIHP program parameters, an MIHP provider may request a program exception. The exception process is documented in both the Medicaid Provider Manual MIHP policy and the MIHP Operations Guide.

The process can be confusing, especially if the MIHP provider rarely or has never requested an exception.

The following circumstances require approval:

- Initiation of services for a child over 12 months of age
- Continuation of services beyond 18 months of age
- A beneficiary whose *Risk Identifier* scores “no risks” but who could benefit from MIHP services

The program exception request must be submitted to MDHHS MIHP staff for review for all beneficiaries, including those enrolled with Fee for Service (FFS) and those enrolled with a Medicaid Health Plan (MHP).

To request an exception, the MIHP provider must submit the following written documentation to the MDHHS MIHP team, via fax or encrypted email:

- The Medicaid ID and date of birth
- Payor source for beneficiary
- Type of exception
- Rationale for the exception

The rationale for the exception must include:

- Identified risks
- Detail of services to be provided, including but not limited to:
 - A brief plan on support to be provided to the beneficiary
 - Anticipated number of visits
 - Brief transition plan

Beneficiaries with FFS Medicaid: MDHHS MIHP staff will review the request and provide the final decision to the MIHP provider.

Beneficiaries enrolled with an MHP: MDHHS MIHP staff will review the request and recommend the decision to the MHP. The provider will be copied on the recommendation email sent to the MHP. MHPs are responsible for processing prior authorization requests for the services, according to their utilization management processes (e.g., for beneficiary exceptions).

Note:

- A risk score for Birth Health does not have a plan of care. However, services may still be offered for the beneficiary based on the professional judgement without requesting an exception.
- If a response has not been received by the MIHP team within 5 business days, please follow up by email at mihp@michigan.gov
- Requests must receive approval before exception services are provided unless an emergency is documented on the Professional Visit Provider Note (PVPN) or Contact Log.
- MIHP providers must keep all written documentation regarding the MDHHS MIHP exception decision in the beneficiary's chart.

Agency Directory Contact Information

MDHHS MIHP staff has received numerous reports of failed attempts to reach MIHP coordinators using the phone number and/or mailing address in the Coordinator Directory. Accurate contact information is a requirement, including coordinator information, mailing address and phone number. Voicemail and answering services must also include instructions in case of an emergency.

We strongly encourage you to check the Coordinator Directory as well as the voicemail/answering service for the phone number(s) listed, as this information may have changed resulting from temporary changes during the pandemic. If there are any changes required for the coordinator, mailing address and/or phone number, please inform MDHHS MIHP immediately by utilizing form [5915 Agency Information Change Request Form](#) from the MIHP website.
