

Michigan Public Service Commission
2022 Year End Summary
Telecommunications Rights-of-Way Permits
Public Act No. 48

Pursuant to Public Act No. 48 the Michigan Public Service Commission received notification of 149 permit applications during 2022. There were 136 new permits and 4 extensions to existing permits approved in 2022. Of the 140 permits approved in 2022, 37 were unilateral permits and 103 were bilateral permits. A total of 3 permits were denied in 2022.
