

**Michigan Public Service Commission
2008 Year End Summary
Telecommunications Rights-of-Way Permits
Public Act No. 48**

Pursuant to Public Act No. 48 the Michigan Public Service Commission received notification of 84 permit applications during 2008. There were 32 new permits and 52 extensions to existing permits approved in 2008. Of the 84 permits approved in 2008, 74 were unilateral permits and 10 were bilateral permits. A total of 0 permits were denied in 2008. Below is a summary of the permit notifications received from municipalities in the State of Michigan during 2008.
