# Workforce Development through Contractor Support

- Elevate and Detroiters Working for Environmental Justice are partnering on an EPA Environmental Justice grant to support minority contractors in Detroit and Highland Park with back-office support, technical training, and access to clean energy projects.
- Similarly Elevate is working with the City of Ann Arbor using foundation funding to connect contractors with electrification education and projects. Work will focus on training for air source heat pump technology.





### **Opportunities**

Support minority-/women-/disadvantaged-/veteran-owned contracting businesses seeking to expand into energy efficiency, solar, and storage. Leverage the design and construction processes for Build Back Better deployment to build technical capacity and practical, hands-on experience.

### **Barriers**

- Lack of Detroit and Highland Park based contractors with experience in energy efficiency, electrification, and solar industry meaning even when individuals are trained in workforce development programs, they do not have jobs in their neighborhoods.
- Small and medium sized firms need back-office support including accounting and insurance services to grow and be able to procure government or utility contracts.
- New technology such as air source heat pumps, EV charging, and solar + storage require education for contractors and residents to increase uptake for decarbonization and utility cost savings.

# Michigan Training & Education Center (MiTEC)

MiTEC Quick Facts

- Fully functioning Weatherization training center
- Mobile in nature
  - No brick and mortar location or buildings
- Credentials
  - Interstate Renewable Energy Council (IREC) accredited
  - Building Performance Institute (BPI) Test Center
    - Two written & field exam proctors
    - Three BPI approved test houses
- Training Houses
  - 1 in Highland Park and 2 in Farwell
- Responsible for training energy efficiency contractors and crew members for the Weatherization Assistance Program and other entities

### Barriers

- Ensuring the needed workforce is aware of the Weatherization Assistance Program (WAP) and energy efficiency career opportunities
- Identifying the WAP as a viable business opportunity
- Connecting workforce to training and WAP services providers

### Opportunity |

- Important things to note
  - WAP in existence for 45 years
  - Strong bipartisan support in Congress
  - Michigan strongly funded
  - WAP production needed throughout Michigan
    - 25 agencies covering every county in Michigan
    - Potential work with multiple agencies
  - Zero dollars tied to marketing to do WAP work
    - Can be a marketing tool for non low-income business base
  - Business Model
    - Michigan's WAP needs an increased workforce
    - Year-round work
    - Price/measure list instead of bidding every job
    - Long term relationships possible with WAP providers
