Some fun facts on Michigan's performance on **utility EE program savings** over time (from ACEEE's State Scorecards).

2008 Scorecard (before PA 295 passed): Michigan ranked 46th in the nation in electric savings and tied with about 20 other states for last in natural gas savings (with zero).

2017 Scorecard: Michigan had climbed all the way to 12th in electric savings and 4th in natural gas savings (savings computed as a percentage of annual sales)

2021 Scorecard (most recent data) Michigan continued to climb, to 8th in electric savings and 2nd in the nation in natural gas savings! Congrats!
