

Manufactured Homes

U.S. Department of Housing and Urban Development (HUD code)

- 1976 Federal regulation begins
- 1994 Major code update
- 1997 EPA ENERGY STAR expanded to include MH
- 2022 Proposed improvements for multi-section (double wide)homes




Manufactured Homes in Michigan

- 193,212 manufactured homes in Michigan
- 4.8% of total housing in Michigan
- Higher percentage than most other Midwestern states








GLE Manufactured Homes Program 2016-2021

Served 403 homes across 21 counties

- Direct install with duct sealing program
- Light bulbs, faucet aerators, etc. plus duct sealing and belly repair
- Health and safety carbon monoxide detectors, fire extinguishers
- High customer satisfaction



Manufactured Home Residents

- Low-income individuals and families
- Elderly and retired often on a fixed income
- Veterans
- Residents who are disabled or unable to work
- Asset Limited, Income Constrained, Employed

OF 4 MILLION HOUSEHOLDS IN MICHIGAN 1.5 MILLION - 39% - STRUGGLED TO AFFORD THE BASICS LIKE HOUSING, CHILD CARE, FOOD, TRANSPORTATION, AND HEALTH CARE.





City of Mankato, MN Pilot Program

- Park manager support to replace 1970 homes in parks with slightly used homes
- Buy unoccupied unit in park, rehab, move family living in older home in the park to the refurbished home
- Replaced 7-8 homes
- Cost: \$37,500 per home, including \$15,000 for home setup, parks paid for removal and demolition (\$10,000)
- City of Mankato Community Development Block Grant funds
- Current Minnesota Housing Rehabilitation Loan Program

Energy Trust of Oregon

Pilot 2017-2020

- Pre-Pilot spent two years creating partnerships with housing, energy and community development orgs
- 50 homes served
- Replace homes built before 1995
- Understand energy impact, quality of life improvements, project costs, and participation barriers

Energy Trust of Oregon

Program 2021-now

- "Early Retirement"
- Eight homes replaced 30 homes in pipeline
- Home replacements take one to three years
- Program navigator resident support, funding coordination, home project planning
- Nonprofit financial literacy support

Oregon Housing Community Services (0% interest, no payment, forgivable loan after 10 years)	\$30,000-\$80,000
Craft3 low interest loan (fixed, low-interest loan)	Up to \$50,000
ETO Utility Incentives	\$10,000-\$16,000

Project costs (demolition, site prep, new home, transport, setup)

SW: \$87,112

DW: \$123,973


Rural Energy Savings Program (RESP)

- Loans to providers of energy efficiency serves in rural areas
- Affordable loans to help consumers implement cost-effective, energy efficiency measures
- Borrowers apply for loan up to 20 years at 0% interest rate with up to 4% of the loan total to be used for startup costs

Michigan State Housing Development Authority

MSHDA Mod

- Financing for modular homes
- Designed to fit into neighborhoods (basements, garages, etc.)
- Support workforce housing need in a community



Manufactured Home Retailers

- Support buyers in purchasing a home
- Arrange home installation, transportation and delivery, set-up and HVAC installation
- Sell a couple all-electric homes each year and has worked with HVAC contractors who install heat pumps
- Introduced us to Family Promise

Community Groups

TrueNorth Community Services

- Able to serve MH through rehab and healthy homes programs
- Cost of repairs can't exceed value of the home
- Willing to refer people to a replacement program

Family Promise of Grand Rapids

Purchase and restore 200 homes in 35 parks

2022: 28 homes

2023: 40 home goal

- Support families with children (for 1 year) to become homeowners
- Cost: \$28,000 to purchase and rehab
- Timeline: 4-6 weeks to remodel and 9 months for family to transition



Long-term Opportunity


- Demand for MH Replacement
- Build coalition of partners
- Develop funding sources
- Define program eligibility requirements



Short-term Opportunities

- Support TrueNorth's efforts
- Outreach to Family Promise of Grand Rapids
- Additional energy efficiency/retrofit programs

Michigan State Housing Development Authority

MI Home Loan

- First-time homebuyers across state
- Repeat homebuyers in targeted areas
- Minimum credit score of 660

Michigan Housing Opportunities Promoting Energy Efficiency Program (MI-HOPE)

Federal ARP funding to support home rehabilitation targeting older homes

Maine State Housing Authority

2008-2010 Pilot

- Replace homes built prior to 1976
- Nine participants 30-year first mortgage
- 26 participants Maine HOME deferred mortgage
- Own land

2018-current Program

- MaineHousing grant \$35,000 and MaineHousing mortgage loan
- 10-year occupancy requirement
- No longer required to own land



U.S. Dept of Housing and Urban Development

Home Investment Partnerships Program (HOME)

- Grants to states and local governments to fund building, buying and rehab affordable housing
- Montana and Washington program use these funds
