



Why submit comments and reply comments?

- Comments submitted will be reviewed and some could lead to revisions in what the Commission formally adopts in an order in the coming weeks.
- New alternatives and revisions are requested by July 17
- Reply comments are requested by August 9
 - → Reply comments should be responsive to initial comments that were filed by July 17 and publicly accessisble in <u>Case No. U-21547</u>.
 - → The process is the same to file initial comments and reply comments

Sound modeling and measurement

- MPSC Staff is working with a consultant to draft sound modeling and measurement procedures to be used by applicants.
 - → When a draft is ready, an email will be sent out to the listserv
 - → Another public meeting may be scheduled to review the draft
 - → Additional time will likely be provided for comments before the sound modeling and measurement procedures would be formally addressed by the Commission.
