  - Lamar will display all WEA messages directed to the county where the display panel is located IF they have an open slot in the their client rotation. Digital display panels apparently have 6 display slots that are displayed for about 20 seconds each in rotation.

- Michigan Association of Broadcasters
  - UP Central LP2 reached out to local EM's 3 will participate in the RMTs.
     Working with them doing weekly test to get them trained properly.
  - Ron 7 counties have COG. Only 4 do the RMTs when should they contact their broadcasters. Contact Dan/Dale (Kalamazoo). See if they can be worked into that.
- State Emergency Communications Committee
  - Tentative meeting scheduled for March 24 10AM revision of state plan.
- National Weather Service
  - Some tests ongoing, sometime this year will allow NWEM sent through IPAWS to come back through the weather radio automatically.
  - Ron working with N. Webster NWS office on process for them to send out alerts as backup for an EM, every year the challenge codes that can be used if they have to call the weather service directly to send out a message. Will not activate WEA, only EAS and Weather Radio.
  - Testing out sending an email to N.Webster when they send an IPAWS message so the NWS can send out a message over weather radios.
- Region Updates Primary Region Representative
  - Region 1
    - Statewide tornado drill, sending out WEA test message (similar to WA state)
  - o Region 2
    - Macomb Co looking into purchasing IPAWS/Mass Notification system.
  - Region 3
    - Keeping up with monthly tests
  - o Region 5
    - 2 outstanding counties without IPAWS MOUs
    - Regional communication board met twice since last meeting
    - 5 counties doing live RMTs
    - Working with local broadcasters on EAS, working on backup process in case IPAWS is down. Use MPSCS fire pagers to trigger alerts at the broadcast station.
    - Berrien Co -live WEA test in January, doing this now on a monthly basis, have done public safety announcements to let the public know what to expect. Nuclear Power Plant working to remove siren system, plan to use WEA as a primary notification system. By doing test monthly allows for reasonable assurance the public is able to receive these alerts. Link in message to a survey tool to answer questions on whether or not they received the test. Seems to be working well so far.
  - Region 6
    - Several jurisdictions have renewed their IPAWS/Mass Notification system contracts (HSGP grant funds)
    - New subcommittee structure, mirroring Interop structure. Previously all 5

subcommittees under one massive group – all blended together. Was confusing. 2 subcommittee chairs. First meeting recently. Regional TIC plan - desperately needs to be updated. Working on a regional basis to do that. Conducting monthly IPAWS testing. Region 7 No report Region 8 No report Other Business o IPAWS Monthly Proficiency Demonstrations - Jaclyn Barcroft FEMA IPAWS office is starting to make good on their promise to remove alerting privileges for alerting authorities that do not complete their proficiency demonstrations.
