

NOTICE OF PUBLIC HEARING
MICHIGAN STATE HOUSING DEVELOPMENT AUTHORITY
PLAN OF FINANCING FOR QUALIFIED MORTGAGE BONDS
TO FINANCE SINGLE-FAMILY HOUSING

The Michigan State Housing Development Authority (the "Authority") will hold a public hearing by teleconference at 10 a.m., May 18, 2022, in accordance with Treasury Regulation §1.147(f)-1 and Revenue Procedure 2022-20, with respect to a plan of financing by the Authority to provide for certain qualified single-family residential mortgage loans to finance the acquisition or rehabilitation, or both, of owner-occupied single-family dwellings in the State of Michigan by persons of low and moderate income, through the issuance of one or more series of bonds of the Authority in an aggregate face amount not to exceed \$900,000,000, (i) some or all of the proceeds of which may refund single-family mortgage revenue bonds or other obligations previously issued by the Authority, and (ii) some or all of the proceeds of which may be used to make or acquire single-family residential mortgage loans. Proceeds not used to refund outstanding obligations will be used to finance the acquisition or rehabilitation, or both, by persons of low and moderate income, of owner-occupied single-family dwellings, whether currently existing or newly constructed, detached units, condominium units, cooperative housing units, or factory-made housing permanently fixed to real property or to refinance certain qualified single-family residential mortgage loans all as permitted under section 143 of the Internal Revenue Code of 1986, as amended.
