<b>Project Results Summary</b> <b>As a result of the NEP grant the community park will have updated and safer play facilities for Village and surrounding area residents. This will result in more park usage.</b>	<i>(SAMPLE RESPONSE) As a result of the NEP in Smithvale neighborhood, property values will increase.</i>
<b>What indicators were used to measure results?</b> <b>Comparing the old worn out and the new equipment. Noting the increased number of park activities booked and the increase in casual park usage.</b>	<i>(SAMPLE RESPONSE) Home sale prices in the neighborhood.</i>
<b>How were the indicators measured?</b> <b>Visually monitoring usage and monitoring booked events.</b>	<i>(SAMPLE RESPONSE) Compared the average sale price at the start of the NEP to the average price at the end of 2-1/2 years.</i>
<b>What were the findings of the measurements including baseline data?</b> <b>Early onset winter weather interfered with monitoring the usage increase but I am confident the new equipment will increase park usage. There has been much interest in the new equipment. There is more interactive, interesting equipment that is bigger, better, and much safer than what was previously available. The new ground covering and landscaping will also add to the appeal and presentation of the park in the Village.</b>	<i>(SAMPLE RESPONSE) Average sales price in the beginning was \$61,000; at the end was \$67,000.</i>

**What Lessons were Learned?**

The Village should strive to provide park upkeep and improvement on a regular basis so that it does not fall back into such disrepair. The park is an asset to the Village and should invite usage both from area residents and people coming into or passing through the Village.

Also, volunteer labor is very difficult to schedule and you can't predict cooperative weather.

*(SAMPLE RESPONSE) Not only have the sales prices increased, the time on the market has decreased. The homes we built had waiting lists as we built them; and other properties in the neighborhood are selling more quickly.*
