

In continuing response to the Coronavirus (COVID-19) pandemic, MSHDA supports and approves the following policy and procedure waivers for Emergency Solutions Grant (ESG) funding as indicated below. Unless otherwise indicated, these waivers apply to both annual ESG funding and ESG-CV funding. **Waivers can be applied retroactively. Subgrantees are responsible to track waiver implementation and provide relevant documentation upon monitoring request (see “Suggestions for Implementation” under Application Requirements).** All waivers are subject to change as additional State and Federal guidance develops.

Service fees associated with gift cards are not included in the incentive total.</p> <p><b>Suggestions for implementation:</b> Identify any participants who are considering a vaccine dose(s) while experiencing homelessness. Document homeless status and incentive provided for each dose (not to exceed \$50.00 per dose) within the participant file. Ensure payments are tracked within general ledger.</p>
<p>Eligible costs for furniture or furnishings for participants engaged in Rapid Re-Housing or Homelessness Prevention services (<a href="#">HUD Waiver</a>)</p> <ul style="list-style-type: none"> <li>Billing Category: Rapid Re-Housing or Homelessness Prevention – Relocation and Stabilization Services (Services)</li> </ul>	<p><u>ESG-CV Only:</u> January 21, 2020 to December 31, 2022</p>	<p>Subgrantees can purchase furniture and furnishings to provide to Rapid Re-Housing or Homelessness Prevention households, under the following conditions:</p> <ul style="list-style-type: none"> <li>Furniture and furnishings are considered on loan to the eligible household.</li> <li>Subgrantees can charge overhead costs (storage, transport) for any furniture or furnishings purchased.</li> </ul> <p><b>Suggestions for Implementation:</b> Catalogue furniture and furnishings as equipment and devise tracking for household use.</p>

Children must be under the age of 13, unless they are disabled. Disabled children must be under the age of 18. The childcare center must be licensed by the jurisdiction in which it operates in order for these costs to be eligible and must be verified and documented in the participant’s file.</li> <li><i>Education Services</i> - When necessary for the program participant to obtain and maintain housing, the costs of improving knowledge and basic educational skills are eligible. Services include instruction or training in consumer education, health education, substance abuse prevention, literacy, English as a Second Language, and General Educational Development (GED). Component services or activities are screening, assessment and testing; individual or group instruction; tutoring; provision of books, supplies and instructional material; counseling; and referral to community resources.</li> <li><i>Employment Assistance and Job Training</i> - The costs of employment assistance and job training programs are eligible, including classroom, online, and/or computer instruction; on-the-job instruction; and services that assist individuals in securing employment, acquiring learning skills, and/or increasing earning potential. Employment and job training services are allowed; these funds may be used for securing employment, acquiring learning skills, and/or increasing earning potential. Learning skills include those skills that can be used to secure and retain a job, including the acquisition of vocational licenses and/or certificates. Services that assist individuals in securing employment consist of employment screening, assessment, or testing; structured job skills and job-seeking skills; special training and tutoring, including literacy training and prevocational training; books and instructional material; counseling or job coaching; and referral to community resources.</li> <li><i>Transportation</i> – Eligible costs consist of participant’s travel to and from medical care, employment, childcare, or other eligible essential services facilities. These include: the cost of participant’s travel on public transportation; mileage allowance for staff using their own vehicle to visit participants; the cost of rideshare services (i.e. Uber, Lyft) to help participants obtain or maintain housing, when other transportation services are not available; and travel costs for staff to accompany or assist participants in the use of public transportation.</li> </ul> <p><b>Suggestions for Implementation:</b> Ensure costs are tracked within general ledger. Note provision in participant file.</p>

Adding this flexibility is critical to limiting the spread of coronavirus among individuals and families experiencing or at risk of homelessness and helping them obtain housing in tight rental markets during the economic downturn caused by coronavirus.</p> <p><b>Suggestions for Implementation:</b> Interested subgrantees should notify the <a href="#">assigned Homeless Assistance Specialist</a>. Agencies must have a hazard pay policy (or amended Workers Compensation policy) that details the amount, length of time, eligibility, determination, and recordkeeping</p>

<p>Allowance of hotel costs to support non-congregate emergency shelter (<i>MSHDA Waiver</i>)</p> <ul style="list-style-type: none"> <li>Billing Category: Emergency Shelter – Shelter Operations</li> </ul>	<p><u>ESG-CV Only:</u> January 21, 2020 to December 31, 2022</p>	<p>CoCs and LPBs can use funding from the emergency shelter operations budget line to cover the costs of hotel or motel stays for emergency shelter necessitated by COVID-19. CoCs and LPBs are encouraged to consider all sources of available funding for these costs, including the MDHHS Emergency Shelter Program (ESP) and Federal Emergency Management Assistance (FEMA). Counties that have FEMA pre-approval for hotel usage for eligible populations must coordinate with their Emergency Operations Center and utilize this resource— ESG-CV funds should only be used for non-FEMA eligible households. The allowable cost per night is limited to \$85.00. Hotel stays cannot exceed 30 days without prior approval from the assigned MSHDA Homeless Assistance Specialist.</p> <p><i>(Monitoring note: From January 21, 2020 to September 30, 2020, hotel costs for non-congregate emergency shelter were eligible costs under annual ESG funding.)</i></p> <p><b>Suggestions for Implementation:</b> Ensure costs are tracked within general ledger. <p>Expanded eligible costs for Street Outreach services (<i>HUD Waiver</i>)</p> <ul style="list-style-type: none"> <li>Billing Category: Street Outreach – Essential Services</li> </ul>	<p><u>ESG-CV Only:</u> January 21, 2020 to December 31, 2022</p>	<p>Subgrantees can cover costs for installing and maintaining handwashing stations and bathrooms (e.g., porta potties) in outdoor locations for people experiencing unsheltered homelessness. Allowing ESG-CV funds to pay for the costs of handwashing stations and bathroom facilities will help prevent the spread of coronavirus by providing people living in unsheltered locations regular access to bathrooms and the ability to wash their hands.</p> <p><b>Suggestions for Implementation:</b> Ensure costs are tracked within general ledger.</p>
