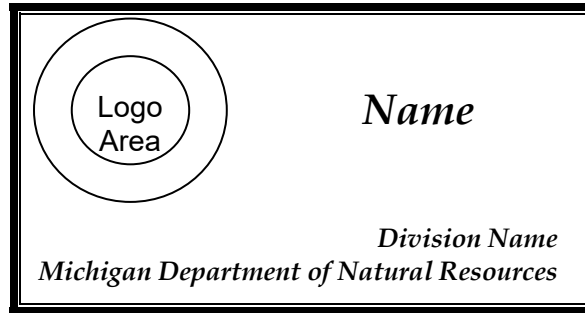


DNR NAME BADGE

For Full Time Employees (FTE) and qualifying Part Time Employees

Name badge:

- Shall be rectangular; 1-1/2" x 3" x 1/16" with rounded corners.
- Shall be brushed Euro Gold metallic foil face over a black plastic core.
- Shall have DNR logo "lapel pin" affixed to the upper left corner.
- Shall be laser engraved with employee name, division name and department name.
- Shall be available with magnetic back fastener or pin back fastener.



Note: corners of badge will be rounded.

Employee name shall be first and last name only; no middle initial, no title.

Division name shall be engraved as follows. Any changes must be authorized by DNR Procurement Services.

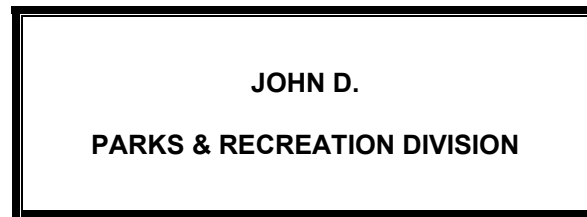

For State Worker 4 (STW) Employees – Parks & Recreation Division / Law Enforcement Division

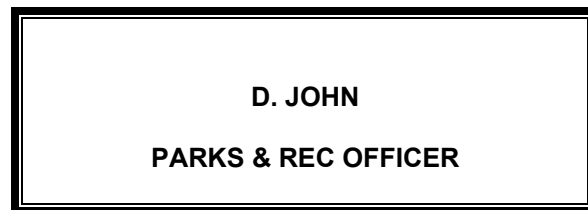
Name badge:

- Shall be rectangular; 1" x 3".
- Shall be White lettering on Walnut background.
- Shall be engraved:
 - a. First Line: Employee's first name with first initial of last name,
 - b. Second Line: Parks & Recreation Division.
- Shall be available with clutch fastener, pin fastener, clip fastener, or magnetic fastener.



Options/Cost:

Badge with clutch fastener:	V400	\$3.50 each
Badge with pin fastener:	V405	\$3.50 each
Badge with clip fastener:	V410	\$3.50 each
Badge with magnet fastener:	V415-MAGNET	\$3.50 each

 - Shall be BK Lettering / GD background

Shipping

Delivery:
