Legislative Action

The Legislative Action Subcommittee reviewed draft language of the rewrite for the 911 Act at their last meeting, where a highlight of the suggested changes were discussed as a group. There were some additional suggestions about items previously discussed during workgroup meetings. At this time, the draft bill has been introduced and assigned bill number HB 5026. After

negotiations take place, the draft may look different than what the MCDA has proposed in the current language. At some point, the draft bill will come to LAS for review where the LAS will propose any additional draft changes. When the draft is complete and supported by LAS, it will be sent to the SNC for support. Due to summer break and state budget discussions in the legislature, we do not expect much movement for the bill until the fall.

Please continue to monitor the State 911 Office website at <u>www.michigan.gov/snc</u> for additional meeting dates, which will be added as this process moves forward.

911 Training

Chairperson Mark Barnes announced the newest members of the 911 Training Subcommittee. We would like to welcome Ms. Stephanie Lehman, 911 Director of Barry County Central Dispatch, and Mr. Edward Nettle, 911 Coordinator at the Missaukee County Sheriff's Office to the 911 Training Subcommittee.

Ms. Theresa Hart has been working with the development team for the MiSNAP program to ensure the bugs are corrected. There will be an additional function for the 911 Directors and Training Coordinators with the release of the next phase. When selecting a telecommunicator from your staff, you will be able to click on a continuing education button which will help you see what training cycle the courses attended are applying to. This should be very beneficial to those who are behind in meeting the training standards by more than one cycle.

If you fall behind in the training standards, it is important a plan of action be submitted to Ms. Hart within MiSNAP. The plan of action will detail what you are doing to get the telecommunicator back on track. All plans of action are taken to the 911 Training Subcommittee at their regularly scheduled meetings for approval.

Certification

The Certification Subcommittee has been busy preparing for the last phase of the automation project. We have been testing MiSNAP and the annual reporting forms in the testing environment. Again, thank you to all of the directors who assisted in testing this phase and the feedback provided. The third phase went live July 20, 2021. The Certification Subcommittee will now start preparing the annual reporting forms for 2022 within MiSNAP.

Thank you to all those who applied for the vacant positions on the Certification Subcommittee. Chairperson Rich Feole will be reviewing the letters of interest and discussing the qualified candidates with SNC Chairperson Jeff Troyer. Stay tuned for a future announcement as to whom will fill the vacant positions. She then moved to become the first Executive Director at SERESA in 2010. A statement from Ms. Bartram:

Proud Moments at SERESA:

I am proud of the awards SERESA personnel have obtained together and individually through the APCO awards program. I am proud we did not fail. We were told by other agencies around us that we would be gone in three years and consolidated with a larger center. We have saved our agency's money while providing excellent service and have come in under budget Every. Single. Year! This has allowed us to build up our fund balance, which started at zero, to a healthy amount.

I am proud our staff has been able to use their creativity and develop programs that will help SERESA be better, such as the Peer-to-Peer support team, QA program, training program, the monthly team games, and internal recognition. I feel like it really helps the dispatchers, the ones who are answering those calls every day, have something productive and positive to do – as an outlet for what they are hearing on the phone and radio.

I have deeply enjoyed working on the committees and boards. Being a part of each of these has allowed me to take my career to greater depths than I ever imagined in 1983. When I completed my master's degree in 2013, I was chosen as the student speaker, and I was able to give a student speech at the graduation ceremony at Ford Field. The title of my speech was "Just Imagine". That was a great moment I could not have accomplished without the support of the SERESA Board – and my husband, of course! Just Imagine was written to inspire people to think deeper about what their future could be – with just an adjustment here and there, just imagine what you might do.

When I think of my 40 years in public safety, I look at those small adjustments throughout my career, and those adjustments have taken me from coast to coast, border to border, amazing people all dedicated to a single purpose; the betterment of service to the public and the health of those who answer the call. It has been an incredible career.

FirstNET Authority

Location accuracy for the emergency communications center

As a field advisor and federal employee for the First Responder Network Authority (FirstNet Authority), I <u>serve public safety agencies on all levels</u> <u>and disciplines across Michigan</u>. While our private sector partner AT&T continues to deliver the network that public safety asked for, making coverage and capacity strides with many new site builds over the last few years, FirstNet Authority serves as your advocate, your voice.

Your input can make a direct impact on the current and future system. In hundreds of engagements with public safety nationwide, my colleagues and I heard from first responders who emphasized the need for location-based services and mapping tools to help track personnel and assets. That's why we've made <u>situational awareness a priority</u> for FirstNet.

Z-axis capability

An accurate location is one of the most important pieces of information for 911 call takers and dispatchers. <u>Z-axis</u> <u>capability</u> gives public safety another level of situational awareness not available with traditional GPS. In addition to latitude and longitude coordinates, it provides the vertical location or z-axis of public safety personnel. By tracking this additional location information, telecommunicators can see where responders are during a call, including the height in a

multistory building.

Z-axis capability provides vertical location using the barometric sensor built into smartphones. Most smartphones in use today come equipped with this feature. The barometric sensor helps measure the height above terrain, or the elevation in a building or other structure.

This data is accessed using a vertical positioning service that is available to public safety app developers. To find an app with z-axis capability, check the <u>FirstNet App Catalog</u>. The FirstNet App Catalog identifies public safety apps that have undergone a rigorous verting and approval process to ensure apps are relevant to public safety, have enhanced security and privacy features, and demonstrate reliability.

Z-axis and the emergency communications center

So, with just a smartphone and an app, a responder in the field can track his or her in-building vertical location. Responders in the emergency communications center can use an app to pinpoint the location of personnel. This helps to know when to dispatch additional units or determine what type of equipment to send to the scene.

With location-based services, telecommunicators can track a responder's movement, speed, direction, and orientation. They can also see the height location of a responder in a multistory building or other structure like a parking garage. Through apps, first responders can share their location with their teams on scene and with commanders, incident managers, and dispatchers.

What3Words

Street addresses or the 'closest dispatchable address' do not always point to the right location or entrance, and many parts of America do not have an address, like parks, forests, and waterways.

what3words addresses are precise to a 10ft square, so you can deliver a faster, more resourceefficient response. Every 10ft square has already been assigned a unique 3-word address, which corresponds with the location's GPS coordinate.

Whether it's receiving a what3words address directly from a caller, or via displayed call information in a partner integration like RapidSOS, what3words helps dispatchers easily coordinate teams and field responders to exact locations, so they can reach the incident faster.
