## **Legislative Action**

The Legislative Action Subcommittee workgroups that were formed to help draft the language for the 911 Act (which sunsets in December) have been put on hold for the time being. The Michigan Communications Directors Association (MCDA) representatives are working with their lobbyist and the Michigan Senate or House representative who has agreed to sponsor the bill. Once the bill is in draft form, the LAS workgroups will pick back up reviewing the draft language as it has been submitted, then a final draft bill will be sent to the State 911 Committee (SNC) for approval.

Many of the individuals who are involved in MCDA were also involved in the two workgroups, so they are aware of some of the discussions and information being shared.

With the announcement of recent retirements, there are two vacancies on the subcommittee. If you are interested in serving, please forward a letter of interest along with a copy of your resume to <u>Ms. Lyndsay Stephens</u> by Friday, June 11.

### 911 Training

The 2021 training fund application review has been completed, along with the approval process at the SNC meeting. The information has been released to treasury and as soon as our office receives the distribution summary, it will be sent to the local agencies, input into MiSNAP, and posted on the SNC website.

As a reminder, as of March 17, 2020, all SNC-approved training should be added by the training provider. If you have SNC-approved training that is missing from your training summary, please email our office at <a href="mailto:sncdispatchertraining@michigan.gov">sncdispatchertraining@michigan.gov</a> to have the training added. All internal training should be entered by the agency's training coordinator on a regular basis. As a reminder, a maximum of eight hours of internal training can be utilized towards Module III (continuing education); however, you may enter all internal training if you wish.

The 911 directors should now be receiving an email at the beginning of each month to notify them of any delinquent and/or undesignated telecommunicators. If you believe there is an error with one of your staff, please contact our office at the email above so we are able to research the issue.

#### Certification

At their May meeting, the Certification Subcommittee will begin pulling counties for the second round of compliance reviews. There are updates being done on the forms and requests for documentation which are sent to the local agencies at the beginning of the

compliance review process. This should help eliminate some of the duplicate questions and requests for information that are already submitted to the State 911 Office on an annual basis.

With the recent subcommittee resignations of Mr. Phil Bates, Mr. Robert Stewart, and Mr. Scott Temple, there are currently three vacancies. The State 911 Office and subcommittee would like to thank each of the members for the time and effort they have put into the Certification Subcommittee over the years. All three have brought a great deal of knowledge and experience to 911, and we thank them for their continued service and dedication. Although they are no longer serving on this subcommittee, we know they will continue to help improve 911 in Michigan.

**Mobile Crash Response** 

The OnStar Guardian app brings Mobile Crash Response to any vehicle. The app is designed to use a smartphone's sensors to detect a crash and alert an Emergency Certified Advisor. The advisor will contact the appropriate ECC and provide them with the location.







**Emergency Services** 

The user may also push the red Emergency button to be connected to a specially-trained advisor who will provide verbal medical assistance to anyone in need, and contact the appropriate ECC to provide the location of the incident.
