The New Traffic Crash Advisories


What's New:

- The State of Michigan has implemented the revised UD-10 Traffic Crash Report.

- An updated guide is being developed for Alcohol and Drug reporting on fatal crashes.

With the implementation of the new UD-10 it was decided to resurrect the old Traffic Crash Advisories. These advisories were first started in 1999 as a means of keeping the field updated with changes to the UD-10 and to also offer guidance with some of the more problematic areas on the UD-10. A total of 47 advisories were developed over the years to assist law enforcement with any number of issues that arise while completing the UD-10. The advisories were last updated in 2014 to account for any changes in the UD-10 and to provide any amendments made to the Michigan Compiled Laws. Please disregard any of these previous advisories, as they may no longer be applicable.

Starting with this issue, the new advisories will continue on a regular basis to offer law enforcement officers guidance on the proper completion of the UD-10, highlight new trends or projects on the horizon for traffic crash reporting, and provide further explanation or clarification on specific fields and values on the UD-10.

Officers are encouraged to contact the Traffic Crash Reporting Unit for any questions or issues they may have with completing the UD-10 for possible inclusion in the Traffic Crash Advisories. Chances are someone else around the state may be experiencing a similar situation.


