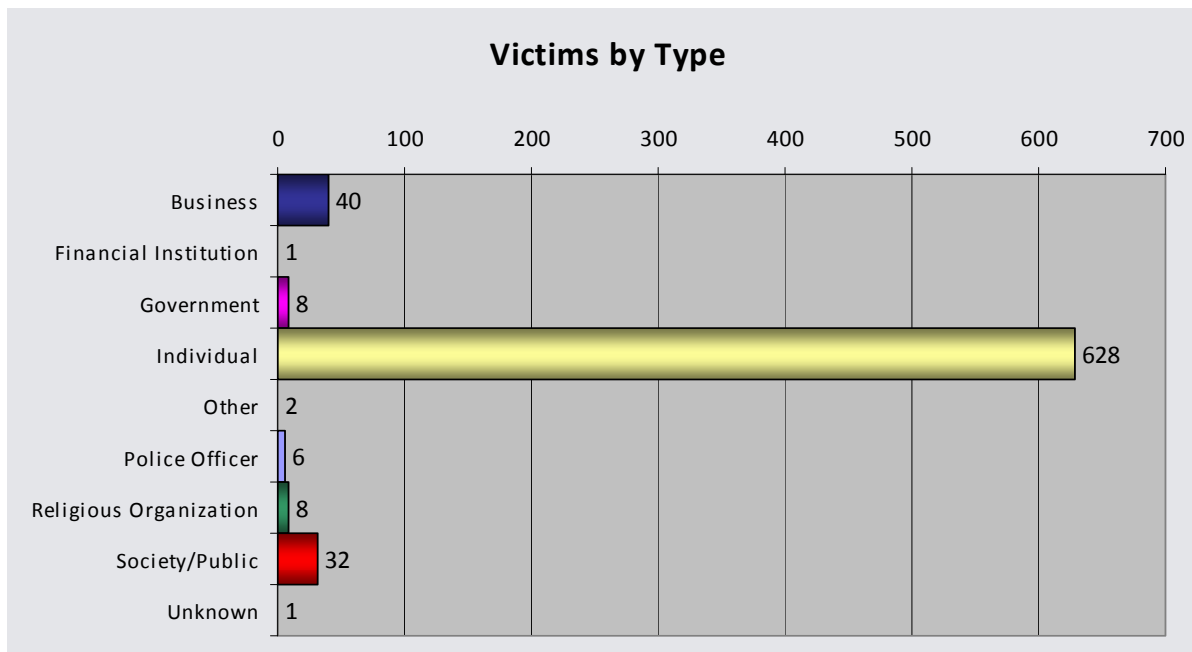


Victim Information

Hate crime incidents are identified on the motivation of the offender(s). Law enforcement investigations determine the objective facts to lead to a reasonable conclusion that the offender's actions were motivated by bias against a racial, religious, ethnic/national origin, mental/physical disability, or sexual-orientation group. Accurate data collection of hate crimes depends heavily on proper training of law enforcement to recognize such incidents and the cooperation and desire of communities/victims to report these incidents to law enforcement.

Definition: Hate Crime is a criminal offense committed against a person or property which is motivated in whole or in part, by the offender's bias against a race/national origin, religion, sexual-orientation, mental/physical disability or ethnicity.

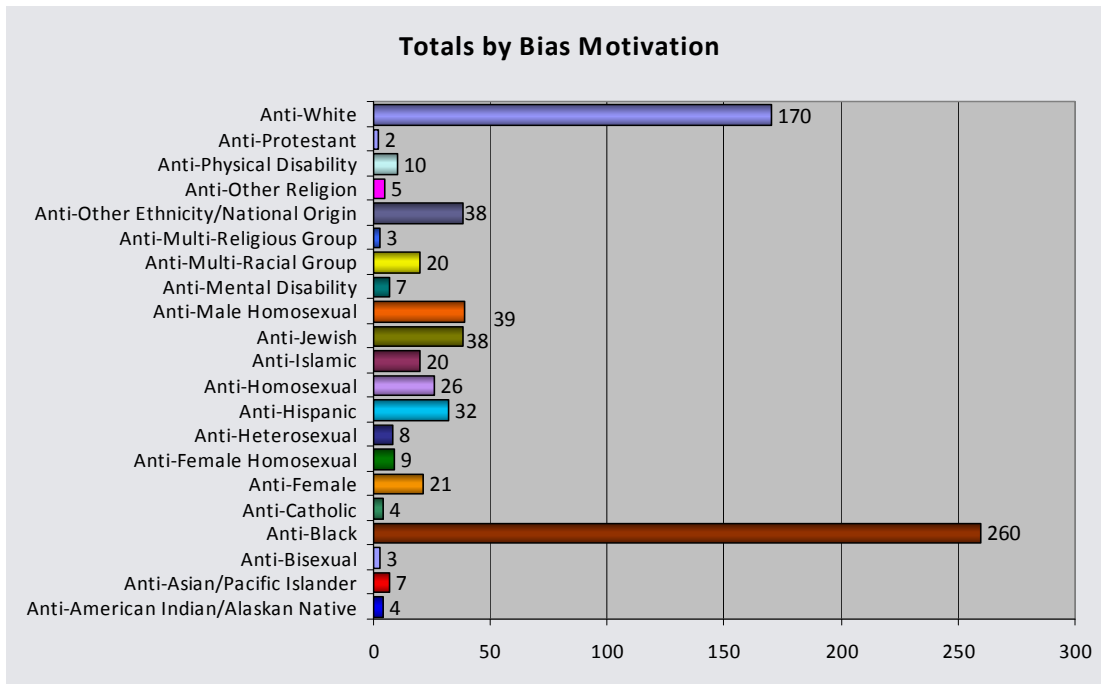
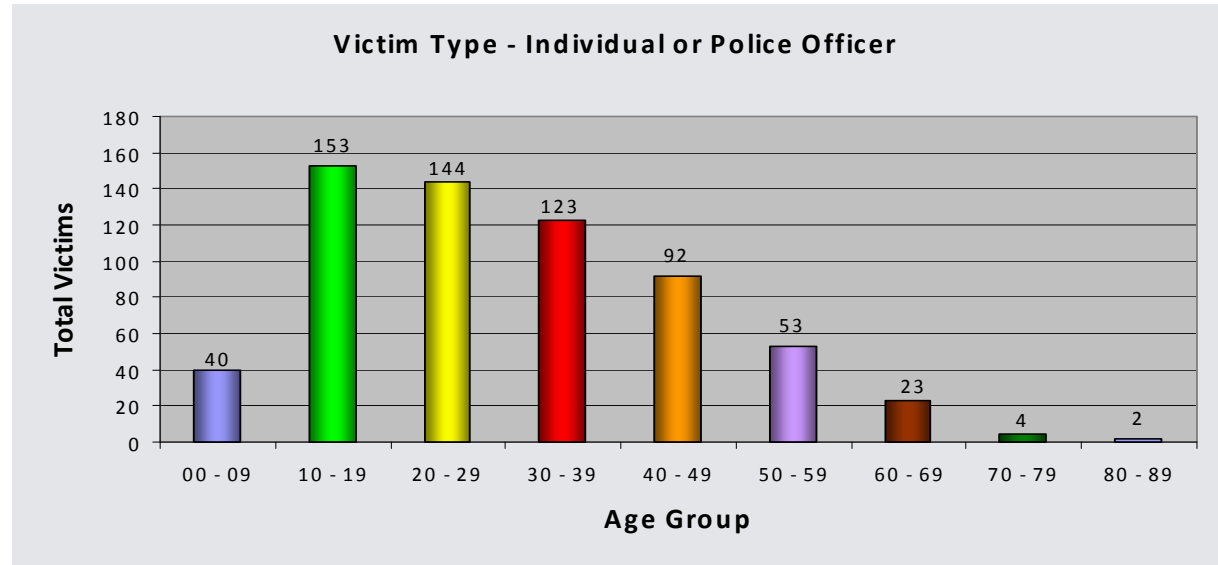


A total of 667 incidents of hate/bias crimes were reported to the Uniform Crime Reporting Program in 2008.

726 victims were reported in these incidents. Victim types of "Individual" and "Police Officer" counted for 634 of those totals.

There were 188 fewer victims of Hate/Bias between 2007 and 2008. This is a reported 20% reduction.

Anti-black was the most targeted bias for the majority of the age groups. Age Groups 60-69 and 70-79 reported Anti-White being the most targeted.

The Intimidation/Stalking offense was reported 30% of the time. Nineteen (19) percent of the incidents reported a Non-Aggravated Assault as the offense. Damage to Property was the reported offense in 17% of the incidents.
