
Section 1:

The Michigan Incident Crime Reporting Program

Incident Based Reporting – Collection of Data

In 1989, the Federal Bureau of Investigation (FBI) Uniform Crime Reporting (UCR) implemented the National Incident Based Reporting System (NIBRS). The Michigan Incident Crime Reporting (MICR) program is Michigan's version of NIBRS. The MICR system was established and certified by the FBI in 1994 and became the state's only method of reporting crime in 2005.

The FBI publishes annual state crime datasets in two different formats. The first, *Crime in the United States*, is the collection of summary-based data submitted to the FBI's Summary Reporting System (SRS). SRS collects complete data from ten offenses (Part 1 Crimes) and only arrest data for an additional 30 offenses. MICR's incident-based data is converted to summary-based data for inclusion in this report. The second, the NIBRS publication, is the incident-based collection. NIBRS collects complete data on 23 Group A offense categories made up of 52 specific offenses and collects arrest data on seven additional Group B offenses. MICR collects complete data on 106 offenses; 67 Group A offenses and 39 Group B offenses. In submitting state data to the NIBRS program, MICR rolls up these 67 Group A offenses into the corresponding 52 NIBRS Group A offenses and submits only arrest data for Group B offenses.



Crime counts may differ between local, state, and federal data collections for a variety of reasons including technical barriers to data transfer and differences in crime counting methodology, the data elements/offenses collected, and report dates. The submission deadline for 2020 crime data to be published/included in the annual report was March 1, 2021.

FBI's Caution in Ranking

Consumers of this data are discouraged from ranking individual jurisdictions, as doing so may lead to incomplete analysis creating misleading perceptions. For more information on this topic, see the FBI's "Uniform Crime Reporting Statistics: Their Proper Use."

Counting Crime

Count Methodology for this Annual Report

Crime counts are determined differently depending on crime category:

- Crimes Against Persons victim counts are used based on an offense hierarchy where only the
 most serious crime per victim is included in instances where the victim was connected to multiple
 offenses.
- Crimes Against Property, excluding FBI SRS Burglary categories (22001 and 22002) and Motor Vehicle Theft (24001) - offense counts are used:
 - For FBI SRS Burglary categories (22001 and 22002) the crime count is the sum of number of premises entered in the commission of burglaries.
 - For FBI SRS Motor Vehicle Theft (24001) the crime count is the sum of attempted motor vehicle thefts plus the number of vehicles stolen for completed motor vehicle thefts.
- Crimes Against Society and Crimes Against All Other offense counts are used.

Victim counts reflect the number of victims for each particular offense file class based on an offense hierarchy where only the most serious crime per victim is included in instances where the victim was connected to multiple offenses.

Offense counts reflect the total discrete offenses submitted to MICR for each particular offense file class.

Incident counts reflect the total number of incidents submitted to MICR for each particular offense file class based on an offense hierarchy where only the most serious crime per incident is included in instances where multiple offenses were attached to an incident.

Examples of Crime Counts

Example 1: An individual is raped and then murdered.

- Murder is a higher ranked offense then rape.
- The rape is NOT included in total rapes.
- One murder is counted.

Example 2: An individual is raped, robbed, and then murdered.

- Murder is a higher ranked offense then rape; rape is not counted.
- Robbery (crime against property; hierarchy not used) is counted.
- One murder and one robbery are counted.

Example 3: One individual is raped, and a second individual is assaulted in one incident.

- Rape is counted for individual one.
- Aggravated assault is counted for individual two.
- One rape and one aggravated assault are counted.

Example 4: Two individuals are victims of larceny in one incident.

One larceny is counted.

<u>Note</u>: The Domestic Violence Report uses "Victim Counts" logic, as described above, regardless of the underlying offense type. The Hate Bias Report and the Law Enforcement Officers Killed or Assaulted (LEOKA) report count all victims. No hierarchy is used.

Notes About the Data

Each year, the Michigan Incident Crime Reporting data is "frozen" on a specific date for purposes of publishing the annual Crime in Michigan report. The frozen set was created on March 11, 2020, for the 2019 Crime in Michigan publication. Any new crime data or updates to previous data submitted by agencies after the "frozen" date is not published in the report.

It should be noted that agencies that were unable to submit complete data by March 11, 2020, will show artificially low crime counts in this report. This may happen when an agency experiences a disruption to the submission of their crime data, for example during a period of transition between records management systems or when programmatic/technical complications interrupt data transfer processes. Therefore, users are cautioned against performing trend analysis or ranking agencies/cities based on their crime data, especially for those agencies/cities that indicate a significant increase or decrease in crime counts from one year to the next.

Users should also take into account the following factors when analyzing changes in the volume and types of crimes: missing data, population density, urbanization, composition of the population, stability of the population, modes of transportation, economic conditions, cultural characteristics, family cohesiveness, climate, strength and policies of the criminal justice system, and crime reporting practices of the citizenry.

When used properly, the data provided in this report can significantly contribute to management and planning activities at local, state, and federal levels, especially by state officials, law enforcement agencies, the legislature, and nonprofit organizations. Subsequent to the freezing of the data underlying this report, which occurred on March 1, 2021, the Benton Harbor Department of Public Safety modified their number of reported aggravated assault incidents. Section 1:

Public Act 319 of 1968

UNIFORM CRIME REPORTING SYSTEM, ACT 319 of 1968

AN ACT to provide a uniform crime reporting system; to provide for the submitting of such report to the department of state police; to require submission of the report by certain police agencies; to require the reporting on wanted persons and stolen vehicles; to require the reporting of information regarding certain persons and unidentified bodies of deceased persons; to prescribe certain powers and duties of law enforcement agencies; and to vest the director of the department of state police with certain authority. **History:** 1968, Act 319, Imd. Eff. July 3, 1968;—Am. 1985, Act 204, Eff. Mar. 1, 1986

28.251 Uniform crime reports; duties of police departments to file, contents.

Sec. 1. The police department of each city or village, any duly constituted police department of a township, and the sheriff's department of each county, once each month upon a date and form prescribed and furnished by the director of the department of state police, shall forward to the department of state police a crime report. Each reporting department shall report only on cases within its jurisdiction and upon which it is making, or has made, the primary police investigation. The report shall be called the uniform crime report and shall cover crimes reported and otherwise processed during the month preceding the month of the report. It shall contain the number and nature of offenses committed, the disposition of such offenses and such other information as the director of state police shall specify relating to the method, frequency, cause and prevention of crime. Under no circumstances shall the name of any person be reported. **History:** 1968, Act 319, Imd. Eff. July 3, 1968.

28.252 Compilation of monthly uniform crime reports; use.

Sec. 2. Upon receipt of the monthly uniform crime reports from the reporting agencies, the department of state police shall prepare a statewide compilation of the statistics contained therein and the resulting statistical compilation shall be available to any governmental law enforcement agency in the state, the judiciary committees of the Michigan state senate and the Michigan state house of representatives, and the federal bureau of investigation, upon request. The statistics made available through the uniform crime report shall be used for the purpose of studying the causes, trends and effects of crime in this state and for intelligence upon which to base a more sound program of crime detection and prevention and the apprehension of criminals. **History:** 1968, Act 319, Imd. Eff. July 3, 1968.

28.253 Voluntary crime reports; inclusion in compilation.

Sec. 3. Any governmental police agency, not falling within the description of those required to submit the monthly uniform crime report set forth in section 1, which desires to submit such a report, shall be furnished with the proper forms by the department of state police. When a report is received by the department of state police from a governmental police agency not required to make such report, the information contained therein shall be included within the monthly compilation provided for in section 2. **History:** 1968, Act 319, Imd. Eff. July 3, 1968.

28.254 Reports of wanted persons and stolen vehicles.

Sec. 4. The chief of police of each city or village and of each township having a police department, and the sheriff of each county within this state, shall report to the department of state police, in a manner prescribed by the department, all persons wanted by, and all vehicles stolen from, their primary police jurisdictions. The report shall be made as soon as is practical after the investigating department either ascertains that a vehicle is stolen or obtains a warrant for an individual's arrest or determines that they have reasonable grounds to believe that the individual committed a crime. In no case shall this time exceed 12 hours after the reporting agency determines that it has grounds to believe that a vehicle was stolen or that the wanted person should be arrested. **History:** 1968, Act 319, Imd. Eff. July 3, 1968.

28.255 Reports of apprehension or recovery.

Sec. 5. When at any time after making a report required by section 4 it is determined by the reporting agency that a person is no longer wanted because of his apprehension, or any other factor, and when a vehicle reported stolen under section 4 is recovered, the chief of police or sheriff of the reporting agency shall immediately notify the department of state police in a manner prescribed by the department. **History:** 1968, Act 319, Imd. Eff. July 3, 1968.

28.256 Inapplicability of act as to traffic misdemeanors.

Sec. 6. The provisions of this act do not apply to misdemeanor traffic cases or to persons wanted for misdemeanor traffic offenses, or for the violation of any city, village or township ordinance. The provisions of this act shall not be construed to in any way affect existing or future laws and procedures governing the reporting of persons wanted for traffic law violations or for the violation of city, village or township ordinances. **History:** 1968, Act 319, Imd. Eff. July 3, 1968.

28.257 Domestic violence incidents; report to state police; contents.

- Sec. 7. The chief of police of each city or village, the chief of police of each township having a police department, and the sheriff of each county within this state shall report to the department of state police, in a manner prescribed by the department, the following information related to domestic violence incidents:
- (a) The number of assaults reported that involve an adult and a minor and the disposition of those offenses.
- (b) The number of assaults reported that involve either 2 male adults or 2 female adults and the disposition of those offenses.
- (c) The number of assaults reported that involve 1 male adult and 1 female adult and the disposition of those offenses.
- (d) The number of crimes reported that involve an individual and his or her spouse, his or her former spouse, an individual with whom he or she has had a child in common, an individual with whom he or she has or has had a dating relationship, or an individual who resides or has resided in the same household; and the disposition of those offenses. As used in this subdivision, "dating relationship" means that term as defined in section 2950 of the revised judicature act of 1961, 1961 PA 236, MCL 600.2950.
- (e) Other statistics the director of the department of state police considers necessary to obtain accurate and reliable data on the incidence of domestic violence in this state.

28.257a Crimes motivated by prejudice or bias; report.

Sec. 7a. The chief of police of each city or village, the chief of police of each township having a police department, and the sheriff of each county within this state shall report to the department of state police, in a manner prescribed by the department, information specified under section 1 related to crimes motivated by prejudice or bias based upon race, ethnic origin, religion, gender, or sexual orientation. **History:** Add. 1991, Act 172, Eff. Mar. 30, 1992

28.258, Sec. 8. DOES NOT APPLY TO UCR.

Contributing Agencies

Section 2:

Law Enforcement Agency Personnel Counts

The following table reflects the number of full-time sworn officers and full-time civilian employees on a Michigan law enforcement agency's payroll as of October 31, 2020. 532 State, County, Local, and Tribal law enforcement agencies collectively reported a total of 24,985 law enforcement employees in 2020. This marks a 0.3% decrease from the 2019 employee count of 25,063*. Of these 24,985 employees, 72.0% are sworn officers, while civilian employees make up the remaining 28.0%.

Section 3:

Michigan Index Crimes and Rates

The FBI, as part of its SRS annual report, tracks Part 1 Index Violent and Property crimes. Violent Index crimes consist of Murder, Rape, Robbery, and Aggravated Assault. Property Index crimes consist of Burglary, Larceny, Motor Vehicle Thefts, and Arson. Though MICR collects and reports NIBRS data, for its annual report it uses hierarchical counting rules and groups its offense file classes into the corresponding Index Crime categories in order to simulate the Index Crime Reports published by the FBI's SRS Crime in the United States.

<u>Note</u>: Because the most recent FBI Crime in the United States reports do not include Arson in their calculation of property crime rates, Arson is not included as an index crime in this report.


2020 Summary:


- <u>Violent crime</u> increased 12.0% from 2019, and increased 8.6% since 2016, primarily led by a significant increase in aggravated assaults. Murders were also up significantly in 2020.
- Robbery decreased steadily over the five-year period and Rape continued to decrease in 2020 since its peak in 2018.
- Property crime decreased 12.0% from 2019 and decreased 25.7% since 2016.
- Burglary, Larceny, and Motor Vehicle Theft each decreased significantly in the five-year period, though Motor Vehicle Thefts increased slightly from 2019 to 2020.










Crime Rates













Robbery is a type of theft committed in the presence of the victim. The victim is directly confronted by the offender and is threatened with force or is put in fear that force will be used. Robbery involves a theft or larceny but is aggravated by the element of force or threat of force. Because force is or can be involved, it is included within the violent crime calculations. MICR offenses included for this report are 12000 and 12001.




Crime Rates


Crime Rates





Burglary-Forced Entry is the unlawful forcible entry of a building or other structure with the intent to commit a theft or felony. Burglary-Entry Without Force is the unlawful entry, without force, with the intent to commit a theft or felony. Neither apply to motor vehicles or coin boxes. As of this year, counting logic for Index Crime burglaries has changed to closer resemble the logic used by the FBI. For these charts, burglaries were recalculated using this updated logic (counting premises entered per offense instead of offenses) retroactively through 2017. Data prior to 2017 is in a different format and could not be converted.






Crime Rates

Crimes by Day










Crime Rates

Crimes by Day











2020 - Hate/Bias Crime



Definition: A Hate Crime is a criminal offense committed against a person or property which is motivated in whole or in part, by the offender's bias against a race, ethnic/national origin, religion, sexual orientation, or mental/physical disability group.

Note: Michigan's Ethnic Intimidation Act, Act 328 of 1931, as amended, Section 750.147b, was written to allow for stricter penalties for hate crimes. Ethnic intimidation is a felony punishable by imprisonment for not more than two years, or by a fine of not more than \$5,000, or both. This act requires that all offenses be reported within an incident.

An incident is one or more offenses (crimes) committed by a person or group of persons acting together, at the same time and place. A victim of multiple hate crime offenses is counted for each offense.

Data Element Version Change Log

MICR implemented versioning to the schematron in April of 2019. The first version (Base) was followed by new versions approximately every six months. Though MICR is currently only accepting the two most recent versions, during 2020, MICR was accepting all versions to allow vendor updates. Section 6: Glossary

Adult - The definition differs under Federal and Michigan law. Federal law states an adult is a person who is 18 years of age or older. Michigan law states, an adult is a person who is 17 years of age or older. (In this report, the definition follows Michigan law.)

Aggravated Assault - An unlawful attack by one person upon another wherein the offender uses a weapon or displays it in a threatening manner, or the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.



Animal Cruelty - Intentionally, knowingly, or recklessly taking an action that mistreats or kills any animal without just cause, such as torturing, tormenting, mutilation, maiming, poisoning, or abandonment.

Arrest - To seize, hold, summon or cite by legal authority.

Arson - To unlawfully and intentionally damage, or attempt to damage, any real or personal property by fire or incendiary device.

Automatic Weapon - Any firearm which shoots, or is designed to shoot, more than one shot at a time by a single pull of the trigger without manual reloading.



Burglary - The unlawful entry of a structure to commit a felony or a theft. Breaking and entering into motor vehicles is not included in this classification.

Clearance - The solving of a particular crime, either by the arrest of the offender or through exceptional means.

Clearance by Arrest - When an offender has been identified with sufficient evidence to be formally charged.

Commercialized Sex/Prostitution - Illegal activities related to engaging in normal or deviate, heterosexual or homosexual, sexual acts for profit or gain.



Computer Hacking/Invasion - Wrongfully gaining access to another person or institution's computer software, hardware, or networks without authorized permissions or security clearances.

Crime Rate - Relates the incidence of crime to population so that it can be compared uniformly without regard to population size. (In this report, rates are calculated by dividing the number of crimes by the population of the service jurisdiction. The calculated number is then multiplied by 100,000.)

Criminal Sexual Conduct, 1ST DEGREE - See Michigan Compiled Law (MCL) 750.520b.

Criminal Sexual Conduct, 2ND DEGREE - See MCL 750.520c.

Criminal Sexual Conduct, 3RD DEGREE - See MCL 750.520d.

Criminal Sexual Conduct, 4TH DEGREE - See MCL 750.520e.

Disorderly Conduct - An offense which disturbs the peace and tranquility of the community in general.

D

Domestic Violence - The occurrence of any of the following acts by a person that is not an act of self-defense: causing or attempting to cause physical or mental harm to a family or household member; placing a family or household member in fear of physical or mental harm; causing or attempting to cause a family or household member to engage in involuntary sexual activity by force, threat of force, or duress; and/or engaging in activity toward a family or household member that would cause a reasonable person to feel terrorized, frightened, intimidated, threatened, harassed, or molested.

Driving Under the Influence - The driving or operating of any vehicle while under the influence of liquor or drugs. Embezzlement - The illegal taking, misapplying, or misappropriating of money, or other things of value which have been entrusted to one's care, custody, or control. Exceptional Clearance - Is reported when an investigation has established an offender, there is enough information to support an arrest, and the location of the offender is known, but there is a reason outside the control of law enforcement that prevents arresting, charging, and prosecuting the offender. Firearm - A general term referring to all types of handguns, rifles, and shot guns. Forced Entry (Burglary) - Forcibly entering a structure to commit a felony or a theft. Forcible Rape - Penetration, no matter how slight, of the vagina or anus with any body part or object, F or oral penetration by a sex organ of another person, without the consent of the victim. Forgery & Counterfeiting - The making, altering, uttering, or possessing with intent to defraud, anything false in the semblance of that which is true. **Fraud** - The conversion and obtaining of money or property by false pretense. Gambling - Unlawfully engaging in playing, operating, or assisting in operating a game of chance for G money or some other stake. **Gun** - A general term referring to all types of handguns, rifles, and shot guns. Hate/Bias Crime - A criminal offense committed against a person or property which is motivated, in whole or in part, by the offender's bias against a race, religion, ethnic/national origin, sexual orientation, or disability group. Heterosexual - Of or relating to persons who experience a sexual attraction toward, and responsiveness to, members of the opposite sex. H Homicide (Murder) - The willful killing of one human being by another. Deaths caused by negligence, attempts to kill, assaults to kill, suicides, accidental deaths, and justifiable homicides are excluded from this category. Human Trafficking - Commercial Sex Acts and Involuntary Servitude are illegal activities related to engaging in the trafficking of individuals for recruitment or in the sex trade(s). **Identity Theft** - Wrongfully obtaining and using another person's personal data (name, date of birth, social security number, driver's license number, etc.). Incident - One or more offenses committed by a person or group of persons acting together, at the same time and place. Intimidation/Stalking - To unlawfully place another person in reasonable fear of bodily harm through the use of threatening words and/or other conduct; without displaying a weapon or subjecting the victim to an actual physical attack. Jurisdiction - The geographical range of authority. This term can also be used to refer to an agency. Justifiable Homicide - The killing of a perpetrator by a law enforcement officer in the line of duty or by a private citizen during the commission of a criminal offense. Juvenile - The definition of a juvenile differs for Federal and Michigan law. Under Federal law a juvenile is a person who is under 18, and under Michigan law a juvenile is a person who is under 17. In this report, the definition of a juvenile follows Michigan law. K Knife - Any type of cutting instrument used as a weapon.

L

Larceny - The unlawful taking, carrying, leading, or riding away of property from the possession or constructive possession of another.

Liquor Laws - Unlawfully acquiring, manufacturing, transporting, selling, or possessing intoxicating alcoholic liquor.

MICR - Michigan Incident Crime Reporting

M

Motor Vehicle Theft - The theft or attempted theft of a self-propelled vehicle that runs on land and not on rails; this includes "Joyriding". ("Carjacking" is not included in this classification. It is classified as a Robbery.)

Murder (Homicide) - The willful killing of one human being by another. Deaths that are caused by negligence, attempt to kill, assault to kill, suicide, accidental death, and justifiable homicide are excluded from this category.

Negligent Manslaughter- Deaths that are determined by police investigation to be primarily caused by gross negligence (except motor vehicle accidents which are included in the offense category "All Other").

N

NIBRS – the National Incident Based Reporting System is the Federal Bureau of Investigation's incident-based reporting system in which data is collected on each single crime occurrence.

Non-Aggravated Assault - An unlawful physical attack by one person upon another, where no weapon is present, and no severe injury occurs.

P

Offense - An unlawful act which has been reported to a law enforcement agency.

Percent Change - Calculated by taking the number of offenses for the current year, minus the number of offenses for the previous year, divided by the number of offenses for the previous year, and multiplied by 100.

Personal Weapon - Where the offender uses a part of their body as the weapon (hands, fists, feet, etc.).

Possible Injury - Victim has no visible injury but complains of pain or had momentary unconsciousness.

Property Crimes - Consists of Burglary, Larceny-Theft, and Motor Vehicle Theft. The object of the theft-type offense is the taking of money or property, but there is no force or threat of force against the victim. Arson is occasionally included in this category.

R

Rape - The penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. Assault to rape and attempted rape are included in this classification. Other types of sexual penetration are not included.

Retail Fraud - The theft or misrepresentation to obtain money or property with the intent to defraud while in a store or in its immediate vicinity while the store is open to the public.

Robbery - The taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or putting the victim in fear.

Sex Offenses - Illegal acts done for sexual stimulation or gratification or involving display or exposure of sexual organs. Rape and prostitution are not included in this classification.

S

Statistical - A collection and study of numerical data.

Stolen Property - The buying, receiving, selling, possessing, concealing, or transporting of any property with the knowledge that it has been unlawfully taken outside of the reporting agency's jurisdiction.
