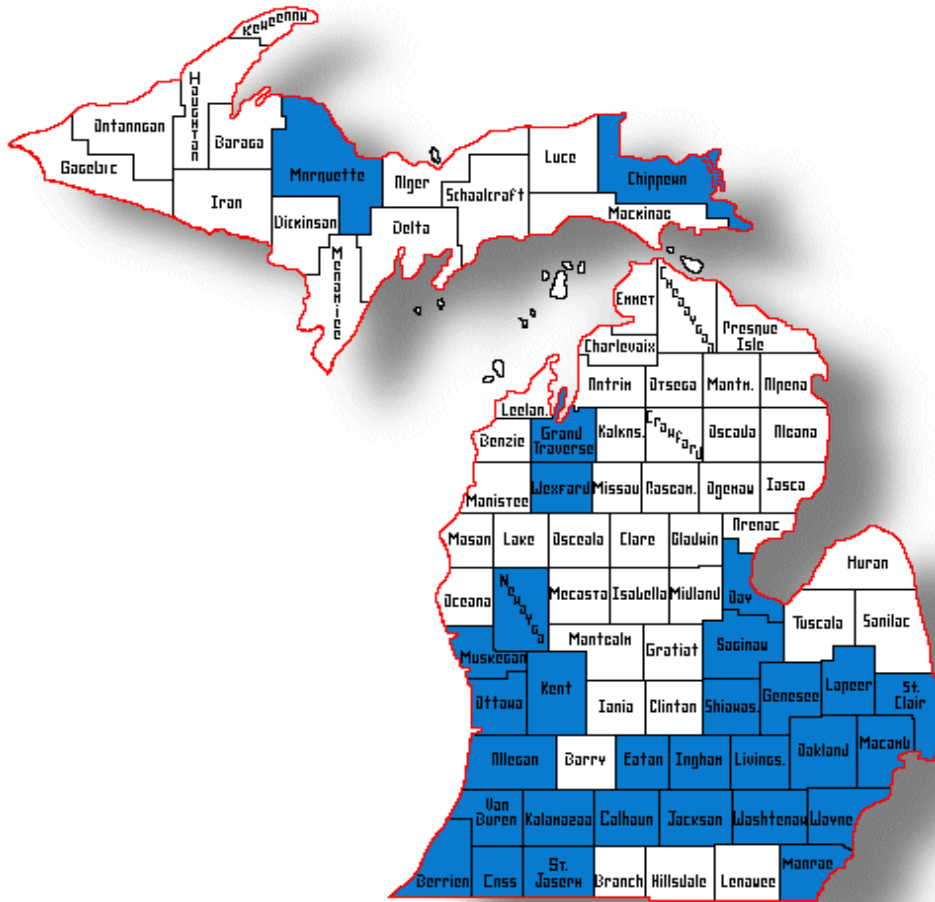

Required enforcement periods will include:

- December 1, 2022-February 28, 2023 (speed enforcement)
- December 16, 2022-January 1, 2023 (impaired driving enforcement)
- May 15-June 4, 2023 (seat belt enforcement)
- July 1-30, 2023 (impaired driving, seat belt, and speed enforcement)
- August 10-September 4, 2023 (impaired driving enforcement)

Elective enforcement periods will include:

- November 21-27, 2022 (impaired driving enforcement)
- April 1-30, 2023 (distracted driving enforcement)

NOTE: Enforcement reports are due no later than 8 days after (the Monday following) the conclusion of each enforcement period.

Exception: Two reports are required on January 9:

One for speed enforcement in December and one for impaired driving enforcement in December.
Speed enforcement activity in January can be reported with February activity on March 6, 2023.
