Financial Status Reports

- Financial Status Reports are due quarterly.
 - January 30th
 - April 30th
 - July 30th
 - October 30th
- Financial Status Reports may be due monthly, only if this was previously agreed upon by the OHSP Project Coordinator and the grantee.

Progress Reports

- Non-Enforcement Grant Progress Reports are due quarterly.
 - January 30th
 - April 30th
 - July 30th
 - October 30th
- Enforcement Grant Progress Reports are due only once.
 - October 30th

Enforcement Reports

- Enforcement Reports are due five business days after an enforcement period. These dates change year to year; the dates for fiscal year 2023 are shown below.
 - If the grantee chose not to participate, no report is needed for elective enforcement periods.
