## Michigan Veterans' Memorial Park Commission (MVMPC) meeting notes April 17, 2023 meeting

- Park maintenance update (Jerry Keeder/Brent West)
  - Jerry noted that Facilities has been doing Spring clean-up at the Park.
  - They are waiting for a couple more quotes for concrete repairs to be submitted; hoping to have before the June MVMPC meeting.
  - Jerry, Brent, John Juarez, and Dana Schafer will meet once all bids are in.
  - The Commission previously approved funding to complete necessary concrete repairs. Will only need to vote if price is above \$50,000.00.
  - Jerry also noted it will be difficult to meet a target date of July 3<sup>rd</sup> for repairs to be completed due to supply chain issues delaying projects and scheduling.
  - Once he has quotes, he will have a better idea of potential start/completion timeframe.
- Approve March 20, 2023 meeting notes
  - Greg Havrilcsak motioned to approve the March 20<sup>th</sup> meeting notes; Danny Craig seconded; all approved.
- Financial statement
  - Reviewed 2<sup>nd</sup> Quarter MVMP financial report; no updates since last meeting.
  - Still in good standing and adequate funding is available for concrete repairs.
- Chairperson update
  - John nominated Andrew Cosgrove to be the new Chair of the MVMPC.
  - John motioned to approve; Greg seconded; all approved.
- Michigan Society of Sons of the American Revolution (MISSAR) monument
  - The Sub-committee completed its review of the application and determined all requirements were met.
    - The final proposal includes donation of a Liberty Tree (Jefferson elm) and a memorial plaque in commemoration of the 250<sup>th</sup> Anniversary of the Founding of the United States of America.
    - MISSAR will sign an MOU and include \$600 for a maintenance fund for the memorial.
    - If final approval is given by the MVMPC, they would like to proceed with the donation and have a dedication ceremony in October 2023.

- The Sub-committee asked the Commission to vote to approve.
  - o Danny motioned to approve; Andrew seconded; all approved.
- Location of tree and memorial is to be determined in the next couple of months.
- **Dana** will prepare notice to be sent to the MISSAR advising them that the application for donation has been approved by the Commission.
- **John** will send the notice and advise them we will follow up on location for the memorial.
- DAR/SAR Vietnam War POW's ceremony was held on April 11, 2023
  - Event was held at the Michigan Vietnam Veterans Monument and went well.
  - John has reached out to the DAR for photos from the event.
