MVAA Director Zanata Adams addressed the Board on her recent MVAA activities. Director Adams will be attending the upcoming National Association of State Directors of Veteran Affairs Conference, adding this conference is really where the MVAA gets a lot of information on best practices. Director Adams reported that there are several States that are looking at the MVTF model for grants to veterans and would like to meet with Director Holm soon. Director Adams reported that MVAA will be doing a lot of VCAT strategic planning with the federal VA to see if they would consider helping fund VCAT. Director Adams reported that she attended the Governor Suicide Prevention Challenge held in Washington D.C. last month and gave an overview on the status of that program, adding that 1.2 million dollars are earmarked for the Governor's Suicide Prevention efforts. Director Adams reported that Michigan will be getting its first State Cemetery in Michigan in Crawford County. Director Adams asked the Board to save the date for the Veterans Gala which will be held on November 5, 2022, at the Lansing Center. Ticket and hotel information for the Gala will be going out soon. MVTF Director Holm gave an update on the status of the MVTF electronic application. A brief discussion followed with Erik Napieralski answering questions pertaining to how this electronic application will improve the overall application process for MVTF and Michigan counties. Director Holm reported that the MVTF has hired a new agent who will be taking applications in and for Wayne County, adding this agent will start taking applications in the next couple of weeks. Director Holm gave clarification of the Attorney General's Office opinion on Board quorum attendance and requirements. The AG's opinion pertains to all the State's Boards and Commissions requirements.
