Unfinished Business

Director Holm and Vice Chairperson McIvor are scheduled to tour the United We Smile facility in Traverse City with State Representatives and Congressman LtGen. Bergman on July 25, 2025. Holm invited anyone who would like to attend the tour to do so. A brief discussion followed. Director Holm reported on the possibility of a Strategic Program Subcommittee presentation in August, along with VRAD and MVE lab updates. MVAA Director Love and MVTF Director Holm had a meeting with the Texas Veterans Land Board discussing the possibility of a loan program for Michigan veterans. Holm also reported that during the meeting with Texas VLB it was suggested that Michigan could start a pilot program using available funds. A brief discussion followed. Director Holm will gather more information and will update Treasury to discuss options. Holm reported that Treasury will be providing their semi-annual corpus update at our MVTF Board meeting in August. Director Holm will be exploring collaboration opportunities with the Michigan Department of Natural Resources to seek a "win, win" for the DNR and veterans. Director Holm reported that he is hopeful that the last MVTF board vacancy should be filled by the Governor this month. MVTF Chairperson Dempsey inquired about the status of the 2026 Congressional Medal of Honor donation request. A brief discussion followed.

New Business

MVTF Director Holm suggested to the MVTF Board that the October board meeting be held in Traverse City and is hopeful that the VFW in Traverse City will allow us to hold our meeting there.
