Unfinished Business

MVTF Director Holm reported that, to date, the gubernatorial appointments for the MVTF Board members whose terms are ending, and the vacant board spot appointment have not been released yet leaving one vacancy and two Trustee terms expiring February 24, 2025. A brief discussion followed.

New Business

MVTF Director Holm reported on the upcoming MVAA Leadership Summit, which is scheduled to be held May 19-21, 2025. A brief discussion followed. Director Holm asked the MVTF Trustees if they would consider changing the June 10, 2025, board meeting location from Lansing HQ to be held at the VFW National Home in Eaton Rapids, with a tour of the facility to follow the meeting. Director Holm reported that the MVTF Board officer nominations for Chair and Vice Chair are due.

A MOTION (Paul McIvor/Rodney Loonsfoot) to hold the MVTF Board Meeting at the VFW National Home on June 10, 2025, passed and carried.

A MOTION (Jim Wallace/Gregory Spight) to nominate the current officers; namely, Chairperson James Dempsey and Vice-Chairperson Paul McIvor, to continue to serve as Chairperson and Vice-Chairperson and to make the exception to the two-year rule as stated in Article II, section 2 Membership & Officers of the MVTF by-laws, passed and carried.

Strategic Programs Sub-Committee Reports

Chairperson Dempsey reported that he received a request for the MVTF to consider supporting the upcoming Congressional Medal of Honor Society National Convention in 2026 to be held in Detroit (handout provided). A brief discussion followed. Director Holm reported on the proposal from the VFWNH to fund the continued operation of the Veteran Regenerative Agriculture Demonstration (VRAD) Farm Program in the wake of their loss of the WLCC federal grant. VRAD will provide veteran with skills in regenerative farming, entrepreneurship, fostering sustainable agricultural initiatives while also creating new career pathways for veterans. The VFW National Home is committed to covering 50% of the program costs for the remainder of the year and next year. They are seeking additional funding from MVTF to cover the remaining balance (handout provided).

A MOTION (Jim Wallace/Rodney Loonsfoot) for MVTF to cover the remaining balance of the VRAD program costs to the VFW National Home in the amount of \$70,000.00, passed and carried.

MVTF Board Activities

Trustee Wallace reported that he attended the American Legion Winter Conference which was held in Port Huron adding that it was well attended. Trustee Loonsfoot reported that he was asked to represent Tribal Veterans at the upcoming Leadership Conference, adding that he will be speaking the first day of the conference. Trustee Loonsfoot also reported that his Charter (National American Indian) is having their first convention in May. A brief discussion followed.

MVTF Staff Activities

MVTF Director Holm reported that he attended the NASDVA Conference which was held in Washington, D.C. Holm reported that he was able to network with many vendors that attended and gave an overview of the entire conference. A brief discussion followed.
