### Unfinished Business

Director Holm gave an update on the funding situation for the SalesForce online application project that was previously approved by the Board. DMVA Fiscal stated that it would be necessary to request a legislative transfer of \$200,000 from the Grants line of funding (68810) to the Administration line of funding (68800) in order to cover the costs for the SalesForce online application project.

MVTF Director Holm gave a brief update on the Congressional Medal of Honor Society annual conference host committee meeting he recently attended. A brief discussion followed.

A MOTION (Paul McIvor/Gregory Spight) for approval to request a legislative transfer from Grant funding (68800) to Administrative funding (68810) of up to \$200,000 to be allocated for the Salesforce online application, passed and carried.

### New Business

MVTF Director Holm discussed that he plans on attending the upcoming NASDVA (National Association of State Directors of Veterans Affairs) meeting, which is being held March 1-4, 2026, asking for Chairperson Dempsey to consider attending. Trustee Loonsfoot indicated that he will more than likely be attending that meeting as well.

Director Holm reported that the FY25 report is complete and that he intends to share that with the board soon. Holm reported that in 2025, \$2 million was given out with just over 900 applications. A brief discussion followed.

Holm reported on a new policy proposal for the MVTF Board to consider and approve (new policy was provided via email to the trustees). Holm stated that the new policy proposal recommends giving the MVTF director interim authority to approve certain board review cases up to \$7,000. Holm reported that it will reduce workload on staff and board and it will expedite payment of certain applications. The proposed policy provides that the director may not disapprove any applications reviewed under this authority. Applications that do not meet these criteria will continue to be reviewed by the board of trustees according to the normal process. Board approval for these cases will be treated in the same manner as any other interim application approved by the Board of Trustees.

Director Holm gave an update on upcoming MVTF Trustees' term dates. MDAV State Adjutant, Joanne Skippergosh gave DAV updates stating the there are no concerns currently. Skippergosh reported that there is a DAV State Convention that will be taking place in Traverse City.

MVTF Director Holm reported that he and MVAA Director, Brian Love will be meeting with the Texas Veterans Land Board and Treasury to discuss the possibility of creating a Veterans' Land Loan Program in Michigan.

A MOTION (Paul McIvor/Gregory Spight) to accept the proposed policy for adoption as an approved Board of Trustees Policy (BTP #401), passed and carried.

DeLaRosa reported that Habitat finished work on its first family home from the VFW National Home last week. DeLaRosa also reported that Habitat will be working on veteran service organizations' buildings that are in disrepair. A brief discussion followed.
