**Eligible vehicles:** The license plates listed below may only be issued to a non-commercial vehicle owned or leased by the applicant. The applicant's name must show on the vehicle title as the owner or lessee. The vehicle may be a passenger vehicle, motor home, pickup, or van. These plates are not available for motorcycles.

**Expiration:** Veteran license plate registrations expire on the applicant's birthday, except for the first Ex-POW license plate, which expires the year the Secretary of State issues new plates.

## War, conflict, or special veteran plates:

### War or conflict veteran plate:

You or your spouse must have been in service during the dates given to be eligible for one of these plates.

**Fee:** Regular registration fee. A current plate on the same vehicle may be canceled as credit for this fee.

### Ex-Prisoner of War

**Fee:** No registration fee for the first Ex-POW plate. Regular registration fee for additional Ex-POW plates.

**Eligible vehicles:** The license plates listed below may only be issued to a non-commercial vehicle owned or leased by the applicant. The Combat Wounded Veteran, Merchant Marine Veteran, Military Reserve Member, and Pearl Harbor Survivor license plates are not available for motorcycles.

**Expiration:** Veteran license plate registrations expire on the applicant's birthday.

## Peacetime veteran or military service plates:

To be eligible for these plates, you must be a veteran of one of the following services or events. **Your spouse is not eligible for these plates unless also a member.** *Certificate of Release or Discharge from Active Duty (DD-214) is NOT required for verification of eligibility.*

- Air Force Veteran
  - Army Veteran
  - Coast Guard Veteran
  - Navy Veteran
  - Marine Corps Veteran
  - Past or Present National Guard Member
- Note: the following may only be purchased for passenger vehicles, motor homes, pickups, and vans.*
- Merchant Marine Veteran
  - Woman Veteran
  - Past or Present Military Reserve Member
  - Combat Wounded Veteran (Purple Heart recipient)
  - Pearl Harbor Survivor (stationed in Pearl Harbor on 12-7-41)

**Fee:** Regular registration fee. A current plate on the same vehicle may be canceled as credit for the fee.

**Applicant eligibility:** Only one disabled veteran plate may be owned by an applicant. Disabled veteran plates on additional vehicles owned by an applicant are not permitted unless a co-owner qualifies for the plate.

**Spouse eligibility:** The spouse of a deceased disabled veteran may transfer a permanent or standard disabled veteran plate to a vehicle titled in their name if they do not already own a disabled veteran plate.

**Vehicle eligibility:** The license plates listed below may only be issued to a non-commercial vehicle owned or leased by the applicant. The applicant's name must show on the vehicle title as the owner or lessee. The vehicle may be a passenger vehicle, pickup, or van. These plates are not available for motorcycles or motor homes.

**Disability status:** A disabled veteran plate does not automatically qualify as a disability plate. To obtain disabled veteran plate that is also a disability plate, please complete and include an MV-110 Disability License Plate Application.

## Permanent or standard disabled veteran plates (select only one):

### Permanent disabled veteran (Non-expiring registration. No registration fees apply.)

The following must be submitted as proof of eligibility for this plate type:

- Discharge papers showing honorable discharge from military service.
- A U.S. Department of Veterans Affairs "Rating Decision" letter or Summary of Benefits letter showing the applicant has:
  - A **100% combined disability rating**, or
  - A disability rating of less than 100%, but an **unemployable rating of 100%**.

### Standard disabled veteran (Regular registration fees apply. Registration expires on the applicant's birthday.)

The following must be submitted as proof of eligibility for this plate type:

- Discharge papers showing honorable discharge from military service.
- A U.S. Department of Veterans Affairs "Rating Decision" letter or Summary of Benefits letter showing the applicant has a disability rating of 50-90%.
