All proceeds from the event are deposited in the Homes' Charitable Support Fund (CSF), which is separate from facility operations funds. All private donations to the Homes are deposited in the CSF, and its expenses are authorized by the Homes' Board of Directors, and include member social activities, member entertainment, member-oriented expenditures, equipment for the benefit of MVH members, outreach, and more. Private donations to the CSF allow the Home to *do more* for its members and their loved ones.

## A Pivot on the Jacobetti Replacement

Right, Face. Forward, March.

On March 11, MVH notified the City of Marquette of its intent to [no longer pursue the former Cliffs-Dow property as a potential location for the MVH D.J. Jacobetti replacement](#). The decision comes following more than a year of discussion and negotiations, where the two parties were ultimately unable to align on the issue of liability as it pertains to the former Cliffs-Dow property.

While environmental assessments indicated the site could have provided a beautiful and safe location for the home, the inability to align on liability in the already-constrained time frame compelled MVH to pursue alternate locations.

In this replacement journey, MVH and its governing board had previously identified preferred alternate site(s) and is actively working through those identified alternatives.

MVH remains incredibly excited to replace the Jacobetti, and - contingent on a number of other factors - hopes to break ground in 2025. ## Recognizing our MVH Vietnam Veterans

March 29th was National Vietnam War Veterans Day: a day to honor Vietnam veterans and their families. U.S. combat troops arrived in Da Nang on March 6, 1965, and the last American combat soldier left Vietnam on March 29, 1973 - though troops were there well before, and well after those dates. More than 2.5M Americans served within the borders of South Vietnam, and more than 58,000 lost their lives. Those whose lives were spared returned home to a divided and ungrateful nation.

Recognizing our collective national failure in returning home those who bore the violent and unpopular burden of American foreign policy, MVH graciously took the opportunity in March to partner in an effort to recognize, thank, and honor our veterans who served during the Vietnam War era. Our friends at the Michigan Veterans Affairs Agency (MVAA) hosted an event for our MVH at Grand Rapids veterans, where [MVAA Director Brian Love](#) provided a pin to each MVHGR Vietnam veteran and shared his gratitude on behalf of a grateful citizenry. At MVH at Chesterfield Twp, Residential Home Health sponsored a ceremony to recognize, pin, and honor all MVHCT Vietnam veterans. And up north, MVH D.J. Jacobetti hosted a solemn ceremony, paying tribute to those men and women who answered the call to service at a time when it was unpopular to do so.

Maya Lin designed the Vietnam Veterans Memorial in Washington D.C., and about the design, remarked, "As opposed to pretending it never happened, you have to look it straight in the eye. Then you can turn around and walk back out into the light."

MVH is proud to serve those who answered the call to duty during Vietnam - and we're grateful for their service.

## Veteran Healthcare Expansion

March saw one of the largest expansions of veteran health care in history, thanks to the PACT Act - with the VA rolling out the expansion of eligibility sooner than expected, or required. All veterans exposed to toxins and other hazards during military service are now eligible for VA health care.
