Commission Activities FY 2024-2025 Report to the Legislature (Pursuant to Section 951 of PA 121 of 2024) Prepared by The Office of Global Michigan

Reporting Period: October 1, 2023, through September 30, 2024

Summary:

Public Act 121 of 2024 section 951 requires the following:

Sec. 951. From the funds appropriated in part 1, The Office of Global Michigan is to coordinate with any affiliated commissions established in statute or by executive order to produce a report by January 31. The report must be submitted to the standard report recipients and must include, but is not limited to, the following:

- (a) Total number of people with whom each commission directly interacts through programming.
- (b) Total number of public events that each commission conducted.
- (c) Description of the activities that the commissions initiated to promote cooperation between the commissions.
- (d) A list of any commissions that interact with The Office of Global Michigan.
- (e) Programmatic costs of each commission.

Required Information:

- (a) Total number of people with whom each commission directly interacts through programming.
- a. Hispanic/Latino Commission of Michigan Approximately 10,590
- b. Michigan Asian Pacific American Affairs Commission Approximately 3,500
- c. Commission on Middle Eastern American Affairs Approximately 1,500
- (b) Total number of public events that each commission conducted.
- a. Hispanic/Latino Commission of Michigan (29) 6 meetings, 4 HLCOM events, and 19 sponsored events with community partners
- b. Michigan Asian Pacific American Affairs Commission (36) 4 meetings, 2 MAPAAC events, and 30 sponsored events with community partners
- c. Commission on Middle Eastern American Affairs -(9) 4 meetings, 2 CMEAA events, and 3 sponsored events with community partners
- (c) Description of the activities that the commission initiated to promote cooperation between the commissions.

Community Gatherings

The Office of Global Michigan and the Prosperity Commissions hosted a series of community gatherings events across the state: Grand Rapids, Muskegon, and in Marquette.

All Commissions Convening

The All Commissions Convening held in May 2024 brought together over 150 attendees, including commissioners, state legislative leaders, departmental staff, community organizers, and elected officials.

State of Michigan Engagement Meetings

The Prosperity Commissions have worked with state departments to support strategic stakeholder engagement: Michigan Department of Health and Human Services (MDHHS) Office of Community Violence, the Michigan Economic Development Corporation (MEDC), the Michigan Department of Labor and Economic Opportunity (LEO), and the Executive Office of the Governor (EOG).
