
What is MAT?



A technical assistance framework aimed at strengthening community-based Medication Assisted Treatment for persons using opioids at the intersection of criminal-legal systems

The Facts

- 2,532 people died from drug overdoses in Michigan in 2022. Michigan ranks in the top 3rd for drug overdose death rates amongst all states.
- This epidemic has had a significant impact on communities across the country, leading to increased rates of overdose, incarceration and death.
- The opioid epidemic has significantly impacted the criminal/legal system and it's important to address the need for effective MAT treatment in correctional settings.



Why jail assisted Medication Assisted Treatment?

Increase probability of engaging in treatment post release


Prevent fatal and non-fatal overdoses

Reduce recidivism/reincarceration rates




CBHJ Implementation Framework




Site Exploration

This survey is administered twice; Prior to program implementation, and 6 months post implementation launch








- Includes jail command staff, jail medical, PIHP/CMH and community providers




Graph: Percentage of Positive Screens. Data Source: County A-H 2019 30-Day Baseline, 2019-2021 Quarter 1-5 RODS & Quarter 5 MOUD (n=11,986).

In all time periods, an individual is considered to have screened positive if their RODS screen reported heroin or other opioid use in the past year, use of medications for opioid use disorder (buprenorphine or methadone) in the past year, or current use of medications for opioid use disorder (buprenorphine, methadone, naltrexone). In Quarter 4 & 5, individuals enrolled in MOUD programming without a positive RODS are also considered to have screened positive.


*Difference is statistically significant, +Difference is trending significant.







Sustainability



Future Directions and Outcomes

- CBHJ site certification recognized by the MMRMA
- 412 people were able to enroll in MAT while in jail (*of 4 jails total where CBHJ MAT data collection complete)
- From July 2021 to date, the CBHJ has placed 31 naloxone vending machines in county jails and other community sites
- Changes in attitudes amongst stakeholders regarding in-jail MAT programming
- Relationships built, fostered, and sustained as result of CBHJ MAT model
