

CAWG Influence / Outcomes

CAWG Influence

Website Improvements:

- Sites table was initially "tiles" that couldn't be sorted
- Combining the AOI's with MPART sites and adding site lead contact information to investigation webpages and table.
- Changed the format of MPART site content to not mislead public to think updates would routinely happen
- Searchable FAQs
- GIS layers and data
 - Surface water, fish monitoring, public water supply
 - Working on a new webpage to help residents find files/date they are looking for

CAWG Influence

Website Improvements:

- Created the Resources for Residents page
 - PFAS Basics
 - Take Action
 - Consumer Products
- Revamped the MPART home page
 - Added the "What's New" so public could easily see new listings of MPART sites / areas of interest
 - Added "Featured Topics"

CAWG Influence

Process Improvements:

- Precautionary residential well sampling was implemented
- MPART communication and coordination protocol evolved and routinely updated as necessary
- Continuously working with site leads to post site or area of interest writeups to the web as soon as possible.
- Source investigation on lakes and streams including fish sampling

CAWG Influence – DWEHD

- Result Reporting non-regulated PFAS result reporting by EGLE DWEHD Emerging Contaminants Unit have 48 hr. standard turnaround.
- Data Transparency Public Water Supply PFAS Compliance results are shared right alongside PFAS sites/AOI on the MPART website. Ease of access!
- Continuous Improvement –how we assess PFAS: CAWG challenges EGLE to always consider new and emerging PFAS contaminants for regulation. This has driven EGLE to be proactive in our statewide sampling/assessment of PFAS in drinking water.

CAWG Influence - MDHHS

- MDHHS is incorporating feedback from the CAWG on the MDHHS PFAS page that we are developing.
- The PFAS communications plan that our community engagement and site teams use and is revised each year directly incorporates CAWG feedback from what has been said on CAWG meetings.


