The meeting was held via Skype. The meeting began at 0900 hours on 23 September 2020 and adjourned at 0945 hours. The meeting agenda is attached and posted to the Bay West Collaborative Website.

1. Opening Remarks

P. Walz opened the meeting with a greeting and introductions. The meeting purpose was to discuss environmental restoration program work at the former Wurtsmith AFB.

2. Previous 26 August 2020 BCT Review

- a. 26 August 2020 meeting minutes were finalized on 16 September 2020. The hard copy was placed in the IR, at the Oscoda Library.
- b. Action Items EGLE
 - i. Review Wurtsmith UFP-QAPP and propose metrics that will be used for data quality assessment should QA/QC samples be collected by EGLE, including reconciliation if the agreed upon metrics are not achieved.
 - B. Place agreed to review the QAPP and the split sampling language. B. Place will
 draft a split sampling procedure for Air Force review and comment. The task is <u>not</u> to
 revise the QAPP. This task is in progress and should remain on the agenda.
 - ii. Draft the CTS and MPTS Interim sampling plan or revised SRD.
 - 1. M. Siler stated that T. Buckmaster said the revised plan should be sent to the Air Force within the next week.

4. FIELD WORK UPDATE AND SCHEDULE

Bay West

- a. FT-02 Carbon Change out
 - i. The weekly sampling is underway, with 2-day turn-around time. The 21st GAC changeout is tentatively scheduled for the week of 29 September 2020, dependent on the system results.
- b. SS-57 RAWP Implementation
 - i. The second injection took place 23-24 June 2020 and the third quarterly sampling event took place 20-28 July 2020. The fourth quarterly sampling event is scheduled for the week of 12 October 2020. The next injection event is scheduled for November 2020, pending a review of the October results.
- c. FT-02 RAWP Implementation
 - i. Bay West received the Modification to remove the concrete pad and a concrete underground storage tank. Bay West is currently preparing an addendum to the approved FT-02 RAWP to describe how the concrete pad will be managed and disposed of after its demolition. It was noted that the final disposition of the demolished concrete will be disposal at U.S. Ecology's Subtitle C Landfill in Wayne County. A separate Technical Memorandum/Work Plan is being prepared for the UST removal, since it is not an activity included in the ROD.
- d. Engineered Wetlands Treatment System (EWTS)
 - i. Due to seasonal fluctuations manganese exceeded the discharge criteria in August 2020. September 2020 preliminary results showed all compounds were below criteria.
 - ii. Bay West turned the EWTS off on 13 July 2020 and maintenance was conducted from 29 July to 6 August 2020 in Ponds 2, 3, and 4.
 - iii. Phragmites were sprayed on 31 August 2020.
- e. Annual LTM groundwater monitoring
 - i. The RA-O LTM Annual sampling began in May 2020. Bay West will follow the approved 2019 Sampling Plan. 2020 IRP sites completed: LF-27, LF-30/31, OT-24, SS-05, SS-06, SS-08, SS-21, SS-72, SS-71, SS-57 and WP-04. 2020 remaining sites: FT-02 and OT-16.
 - ii. FT-02 and OT-16 are the only sites remaining. They are scheduled for 13-22 October 2020. Field work will include Saturday, 17 October. Bay West is sending an additional person from St. Paul to help with the sampling. B. Place will notify the Air Force and Bay West if EGLE would like to observe, or split sample at any wells. Upon receiving such notice, Bay West will

coordinate sampling schedule with EGLE to allow EGLE to be on-site for any wells it wants to observe sampling or collect split samples.

Bay West/Wood

- f. VIAP Update
 - i. S. Bashir stated Q2 sampling results are currently under being validated.

Aerostar

- g. Central Treatment System (CTS) Status
 - i. P. Bond stated the CTS is operating as designed, regular sampling confirms SRD requirements are being met, no significant maintenance has taken place or is scheduled.
- h. Mission Pump and Treatment System (MPTS) Status
 - P. Bond stated the MPTS is operating as designed, regular sampling confirms SRD requirements are being met, no significant maintenance has taken place or is scheduled. Run time for both systems (CTS and MPTS) are above 95%.
- i. Remedial Investigation Status
 - i. All items as stated on the Agenda.
 - ii. P. Bond stated the Scoping Meeting Minutes will be finalized after the BCT meeting (23 September 2020).

5. AIR FORCE UPDATES

- a. OWAA 10 parcels
 - i. D. Gibson stated that the Air Force is working on the transfer of the 10 parcels to OWAA, no change from the previous meeting.
- b. Tentative schedule for the PFOS/PFOA RI, with milestones.
 - i. D. Gibson stated the RI is on schedule.
- c. RAB Update
 - i. The next meeting will be held on 21 October 2020. The meeting will be a virtual meeting, held from 5:00 to 8:00 pm.
 - ii. Air Force is Drafting the RAB Agenda. Neither EGLE nor MDHHS will be making a presentation, but both will provide updates.
 - iii. The new Co-Chair, Mark Henry, is working on a replacement for the open seat, and the few available alternate seats.
 - iv. B. Place asked what topics the Air Force planned on discussing. D. Gibson stated the RI and IRA's would be the main topics of discussion. The BCT meeting minutes are placed in the IR and are posted on the MPART website for RAB members to review. The focus of the upcoming RAB is PFAS.

6. EGLE RRD – SUPERFUND SECTION UPDATES

- a. Other RAB topics
 - i. B. Place stated that EGLE will not present at the upcoming RAB, only provide updates. A Townhall meeting is scheduled for 20 October 2020. The DNR will be presenting planned studies from Purdue and MSU on Clark's Marsh. Brandon Armstrong will present on the EGLE's Au Sable surface water investigation and potentially foam.
 - ii. B. Place stated the Wurtsmith ARAR's were submitted 18 September 2020. Comments were also submitted on the Relative Risk Site Evaluation on 17 September 2020.
 - iii. B. Place forwarded the press release from Governor Whitmer to Mr. Henderson to the D. Gibson team on September 22, 2020.

7. EGLE RRD – BAY CITY DISTRICT UPDATES

a. A. Armbruster was not able to attend the meeting the RRD Bay City District did not have any updates.

8. EGLE WRD - UPDATES

- a. Surface water/fish sampling in area
 - i. B. Armstrong will present an update at the Townhall meeting, 20 October 2020.
- b. Oscoda Township Wastewater Treatment Plan (WWTP) update
 - i. M. Siler stated F&V have completed all the sampling but have not received the results. EGLE is scheduling a meeting with F&V to discuss the updated data.

9. MDHHS UPDATES

- a. Residential Well sampling update
 - i. P. Vij stated residential well sampling results have been received. There were 133 wells that were non-detect, 117 wells had detections, but the results were less than the MDHHS comparison values, and 18 wells had detections higher than the MDHHS comparison values. The MDHHS comparison values are the lowest of the two-MDHHS comparison value and MCLs.
 - ii. B. Place confirmed the results were for the whole Oscoda area. She explained that one well had results over the Lifetime health advisory (LHA) of 70 ppt along Van Etten Lake, and the residents are hooked up to the municipal system, the well is not used as a drinking water well.

a. D. Gibson wanted to tell the team that the Saginaw Chippewa Indian Tribe of Michigan has reached out to the AFCEC requesting Government to Government Consultation. B. Place stated the District office has meetings quarterly with the Tribe and will reach out to the staff to see if they would like EGLE to present a Wurtsmith PFAS presentation at the next meeting.

Bay West

- a. FT002 Carbon change out event was completed on 12 June 2020, approximately 99 operational days since the last change out. Next change out tentatively scheduled for the week of 21 September 2020. Weekly sampling started on 24 August 2020.
- b. SS057 RAWP Implementation The second injection was completed 23-24 June 2020. Quarterly performance monitoring sampling was completed the week of 20 July 2020. The fourth and final quarterly sampling event is scheduled for the week of 12 October 2020. The third injection is tentatively scheduled for November 2020, dependent on the Q4 sampling results and weather.
- c. FT002 RAWP Implementation Air Force Contract modification for the transportation and disposal of the concrete pad after it has been demolished has been awarded. Preparation of RAWP Addendum is in process.
- d. Engineered Wetlands Treatment System (EWTS)
 - -EWTS Maintenance event completed in July and August 2020. See August 2020 BCT Meeting Agenda for details.
 - August 2020 post maintenance sampling results: Iron concentration below treatment objectives; manganese concentration above treatment objectives.
 - -September 2020 sampling results: Preliminary data show iron and manganese concentrations below treatment objectives.
 - Phragmites were sprayed on 31 August 2020.
- e. Annual RA-O groundwater monitoring began in May 2020. The previously approved 2019 Sampling Plan is being followed. 2020 IRP sites completed: LF027, LF030/031, OT024, SS005, SS006, SS008, SS021, SS072, SS071, SS057 and WP004. 2020 remaining sites: FT002 and OT016, which are scheduled for October 2020.
