- . Active committees that were exempt from filing the Annual Campaign Statement appear with "Reporting Waiver" next to the committee's name.
- . Committees that were required to file but did not as of August 17, 1979, appear with "Did Not File" next to the committee's name.
- . Note that these charts do not correspond to those compiled for the 1978 elections. In the election charts, loan repayments are subtracted out to avoid inflated receipt and expenditure figures. In this chart, loan repayments are included in the gross expenditure figure.
- . Every attempt has been made to provide accurate figures but errors may be present. Always return to the reports for confirmation of data reported here.
