BURT TOWNSHIP PROPOSITIONS

PROPOSITION 1

Shall the previously voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Burt Township be renewed at 3 mills (\$3.00 per \$1,000 of taxable value) for the period of 2008 through 2010 inclusive for providing general operation, improvement and maintenance of cemetery, airport, streets, roads, sidewalks, street lighting, recreation and grass cutting; and shall the township levy such renewal in millage for said purpose, thereby, raising in the first year an estimated \$117,000.00?

PROPOSITION 2

Shall the previously voted increase in the tax limitation imposed under Article IX, Sec. 6 of the Michigan Constitution on general ad valorem taxes within Burt Township be renewed at .25 mills (\$0.25 per \$1,000 of taxable value) for the period of 2008 through 2010 inclusive for restoration and development of the Grand Marais Harbor; and shall the Township levy such renewal in millage for said purpose, thereby, raising in the first year an estimated \$9,750.00?

ONOTA TOWNSHIP PROPOSITIONS

**PROPOSITION TO RENEW TAX LIMITATION FOR
 PURPOSE OF GENERAL OPERATIONS**

Shall the expired previous voted increases in the tax limitations imposed under Article IX, Sec. 6 of the Michigan Constitution in Onota Township, of 2.0 mills (\$2.00 per \$1,000 of taxable value), reduced to 1.9616 mills (\$1.96 per \$1,000 of taxable value) by the required millage rollbacks, be renewed at and increased up to the original voted 2.0 mills (\$2.00 per \$1,000 of taxable value) and levied for four (4) years. 2008 through 2011 inclusive, for the purpose of general operation in the Township of Onota thereby raising an estimated \$61,000.00 in the first year the millage is levied?
