

# Veteran Designation Application



Military veterans from any branch of the U.S. armed forces with an honorable or under honorable conditions (general) discharge may have a veteran designation printed on their Michigan driver's license or state identification card. Applications for the veteran designation may be submitted by mail or at a Secretary of State branch office. A copy of your DD-214 form must be included with this application. Other documentation may be accepted in lieu of a DD-214. Any veteran documentation enclosed with your application will **not** be returned and will be destroyed. Photocopies of original documents are accepted.

## To add the veteran designation by mail:

Complete the order form below. Pay by check or money order made payable to **State of Michigan**. (Please note: there is no fee to add a veteran designation to a standard state ID card.) Mail your veteran documentation, your renewal notice (if renewing) and the completed application along with the payment to: **Michigan Department of State, Internal Services Section, Lansing, MI 48918**.

Under Michigan law, eligible residents are automatically registered to vote when conducting a driver's license or state ID card transaction with the Secretary of State unless they choose to opt out. If you are already a registered Michigan voter, you may skip this section.
