EXPENDITURES BY POLITICAL AND
INDEPENDENT COMMITTEES

-- INTRODUCTION --

This report shows expenditures by political and independent committees for the purpose of influencing the election of state and local candidates. This includes candidates for state senate and state representative, all state wide candidates, all judicial candidates, and all local candidates in Michigan, It does not include federal candidates.

This report covers the 1986 election cycle, as the information was taken from the 1986 primary and general election reports filed by the political and independent committees.

Only expenditures to influence the election of candidates were used. Therefore, the report does not include expenditures to influence ballot issues, contributions to other independent, political, or political party committees, or the administrative expenses of the independent or political committees.

All the political and independent committees which had not been dissolved prior to the 1986 election year are shown on this report. They are in alphabetical order.

Every attempt has been made to provide accurate and complete information on these expenditures. Any question about a particular entry should be checked against the committee's actual file.

-- REPORT DESCRIPTION --

The following describes each column of the report and the information it contains.

COMMITTEE NAME.

This is the name of the committee from which the expenditure information was taken.

COMMITTEE IDENTIFICATION NUMBER.

This is the committee's identification number.

COMMITTEE TYPE.

This shows whether the committee is a political committee (POL) or an independent committee (IND).

PRIMARY/CONVENTION EXPENDITURES.

This shows the total expenditures reported by the committee for the 1986 primary election and convention cycle. The expenditures from each report filed for that period of time are totalled together and the result is shown in this column. If dashes (-----) appear, that means that no reports were filed by the committee for that period of time.

GENERAL EXPENDITURES.

This shows the total expenditures reported by the committee for the 1986 general election cycle. The expenditures from each report filed for that period of time are totalled together and the result is shown in this column. If dashes appear, that means that no reports were filed by the committee for that period of time.

OVERALL EXPENDITURES.

This adds the totals of "Primary/Convention Expenditures" and "General Expenditures" together. If dashes appear, this means that no reports were filed by the committee for that period of time.

-- ADDITIONAL NOTES --

Occasionally, in either the "Primary/Convention Expenditures" or "General Expenditures" column, symbols will appear before the dollar sign of the expenditures by a particular committee. These symbols are an asterisk (*), a plus sign (+), or a pound sign (#). In the cases where such symbols do appear, it means that one or more expenditure report was not available, either because the report was not filed or was not required. However, in all cases, the dollar figures shown reflect the total of all the reports that were available.

The particular symbol used is an administrative tool to indicate with some degree of specificity which report was not available. An explanation is shown below.

If an asterisk (*) appears:

- A. There was only one (1) primary election report and no convention reports available; or
- B. There were two (2) convention reports but only (1) primary election report available.

If a plus sign (+) appears:

- A. There was only one (1) convention report but no primary election reports available; or
- B. There were two (2) primary election reports but only one (1) convention report available.

If a pound sign (#) appears:

- A. only one (1) primary election and only one (1) convention report were available.
