At the end of each office type, (i.e., state representative, etc.) the dollar amounts are then totalled at the bottom for that office type. These amounts will be shown in the line labelled "Offices Of This Type Total". To the left of the "Offices Of This Type Total", the number of candidates that ran for that office type is displayed.

On the last page of the report you will find two grand totals. The first grand total includes all offices other than supreme court, the second grand total is for the office of supreme court only. To the left of the "Grand Totals", the number of candidates that ran for those offices are displayed.

Candidates seeking the federal offices of President, U.S. Senate and U.S. Congress are not reflected in this statistical report as they are not subject to Michigan Campaign Finance Act. However, copies of the federal reports are filed with the Bureau of Elections.

-- INTRODUCTION --

This report shows total receipts and expenditures for certain candidate committees of candidates who were involved in the 1996 election. The data is taken from the Pre-Election and Post-Election Campaign Statements filed by the committees. Information contained in Annual and other Campaign Statement types are not included in the calculations. The offices shown in this report are:

- State House of Representatives
- State Board of Education
- University of Michigan Board of Regents
- Michigan State University Board of Trustees
- Wayne State University Board of Governors
- Supreme Court

The report is sorted first by the office sought, in the order shown above. Within each office, each candidate who sought that office is listed in alphabetical order.

Every attempt has been made to provide accurate and complete information on these candidates. Any questions about a particular entry should be verified against the candidate's committee file.

-- REPORT DESCRIPTION --

This report comes in four major sections. They are "Candidate Name," "Primary/Convention," "General," and "Overall." Each major section has particular information that is described below.

CANDIDATE NAME

Column 1 - This column shows whether or not a candidate was elected at the 1996 General Election. If nominated and elected, an "E" appears here. If an "N" shows instead, this means that the candidate was either nominated in the 1996 Primary Election or at a Political Party Convention or caucus, but was defeated in the General Election.

Candidate Name - This is the name of the candidate. The candidates are in alphabetical order within each office.

Column 2 - This column shows the party affiliation of the candidate. The acronyms mean the following:

REP	-	Republican
DEM	-	Democrat
LIB	-	Libertarian
WOR	-	Workers World
SEP	-	Socialist Equality Party
RFP	-	Reform Party
NLP	-	Natural Law Party
NPA	-	No Party Affiliation

Identification Number - This is the identification number of the candidate's committee assigned by this office. It is used to access the actual files of the candidate committee.

PRIMARY/CONVENTION AND GENERAL

Cash on Hand - This shows the amount of money the committee had on hand at the beginning of the reporting cycle for the 1996 election cycle. The information comes from the first report available from the particular candidate committee.

Cash Received - This shows the amount of contributions received by the candidate's committee during the 1996 primary/convention reporting period or general election reporting period. The number shown represents the total from the reports filed.

Cash Expenditures - This shows the expenditures made by the candidate's committee during the 1996 primary/convention reporting period or general election reporting period. The number shown represents the total from the reports filed.

In-Kind Received - This shows the dollar amount of the in-kind contributions received by the candidate's committee during the 1996 primary/convention reporting period or general election reporting period. The number shown represents the total from the reports filed.

Whenever dashes (--) appear in place of dollar amounts, this means that no reports were available, either because none were filed or none were required.

In either the Primary/Convention section or the General Election section, occasionally an asterisk (*) will appear. If one does appear, it will be directly under the number "3" or the number "4" in the headings of those sections. This asterisk means that the dollar amount shown represents only one of the two reports normally expected was filed during the particular election cycle.

OVERALL

Cash Available - This figure is the total of the first "Cash on Hand" reported by the committee, plus the total of the cash received from the Primary/Convention section and General Election Section.

Cash Expenditures - This is the total of the cash expenditures from the Primary/Convention section and General Election section.

In-Kind Received - This is the total of the in-kind contributions from the Primary/Convention section and General Election section.

Ending Debt - This is the total of outstanding debts and obligations owed by the candidate's committee. This is taken from the last Pre-Election or Post-Election Campaign Statement filed by that candidate.
