Dear Ms. Woods:

The Department of State (Department) received a formal complaint filed by Carolyn Edmunds against you, alleging a violation of the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.201 *et seq*. A copy of Ms. Edmunds' complaint is provided as an enclosure with this letter.

The MCFA prohibits a corporation from making a contribution to a committee other than a ballot question committee. MCL 169.254. A knowing violation of this section is a felony, punishable by a fine of not more than \$5,000 or imprisonment. MCL 169.254(4).

While the only exception to the prohibition on corporate contributions contained in the MCFA is for ballot question committees, a United States District Court for the Western District of Michigan held in an as-applied challenge to Michigan's prohibition on corporate contributions that if a political action committee does not coordinate the expenditure of its funds with a candidate, then the United States Supreme Court decision in *Citizens United*¹ forbids Michigan from denying a corporation from contributing to that committee. *Mich Chamber v Land*, 725 F Supp 2d 665 (2010). This ruling does not extend to corporate contributions to candidate committees, and the prohibition in section 54 still applies to candidate committees.

Ms. Edmunds alleges you used the East Lansing Film Festival website and email list to promote your candidacy, thereby effectuating a corporate contribution to your candidate committee.

The purpose of this letter is to inform you of the Department's examination of these matters and your right to respond to the allegations before the Department proceeds further. <u>It is important to understand that the Department is neither making this complaint nor accepting the allegations as true.</u>

If you wish to file a written response to this complaint, you are required to do so within 15 business days of the date of this letter. Your response may include any written statement or additional documentary evidence you wish to submit. All materials must be sent to the Department of State, Bureau of Elections, Richard H. Austin Building, 1st Floor, 430 West

Allegan Street, Lansing, Michigan 48918. If you fail to submit a response, the Department will render a decision based on the evidence furnished by the complainant.

A copy of your reply will be provided to Ms. Edmunds, who will have an opportunity to submit a rebuttal statement to the Department. After reviewing all of the statements and materials provided by the parties, the Department will determine whether "there may be reason to believe that a violation of [the MCFA] has occurred [.]" MCL 169.215(10). Note that the Department's enforcement powers include the possibility of entering a conciliation agreement, conducting an administrative hearing, or referring this matter to the Attorney General for enforcement of the criminal penalty provided in section 54(4) of the Act.


The contribution will be reported on my post-election report.

Dear Ms. Woods:

The Department of State (Department) has completed its investigation of the complaint filed against you by Carolyn Edmunds, which alleged that you violated section 54 of the Michigan Campaign Finance Act (MCFA or Act), 1976 PA 388, MCL 169.254, by effectuating a corporate contribution to your candidate committee. This letter concerns the disposition of Ms. Edmunds' complaint, which was filed on October 31, 2013. You filed an answer on November 25, 2013. Ms. Edmunds did not file a rebuttal statement with the Department.

The MCFA prohibits a corporation from making a contribution to a committee other than a ballot question committee. MCL 169.254. A knowing violation of this section is a felony, punishable by a fine of not more than \$5,000.00 or imprisonment. MCL 169.254(4).

The Act also provides that if Department determines there may be "reason to believe that a violation of this act has occurred[,]" the Department is required by law to "endeavor to correct the violation or prevent a further violation by using informal methods." MCL 169.215(10).

Ms. Edmunds alleged that you used the East Lansing Film Festival website and e-mail list to promote your candidacy, thereby effectuating a corporate contribution to your candidate committee. Ms. Edmunds provided a copy of an e-mail message sent from you using the East Lansing Film Festival e-mail list on September 26, 2013. In the e-mail you encouraged the recipient to vote for you. She also provided a copy of a news article pertaining to the situation, in which you admit to the wrongdoing.

In response to the complaint, you acknowledged that you sent the e-mail message but explained that it was a "one-time, unintentional error caused by a technological mishap." You indicated you had made a contribution to the East Lansing Film Festival from the "Friends of Susan W. Woods" bank account and included a copy of the check.

The evidence in this matter supports the Department's determination that there may be reason to believe that you effectuated a corporate contribution to your candidate committee using the East Lansing Film Festival's resources. Upon making this determination, the Department is required by law to attempt to resolve the matter informally. MCL 169.215(10).

A copy of the Department's proposed conciliation agreement, which would informally resolve Ms. Edmund's complaint, is enclosed. "Unless violated, a conciliation agreement is a complete bar to any further action with respect to matters covered in the conciliation agreement." *Id.* Please note that the conciliation agreement acknowledges that you have paid \$280.00 to the East Lansing Film Festival as restitution for the violation.

If you are inclined to execute the conciliation agreement, please return the original signed document to this office on or before March 14, 2014.

Please be advised that if the Department is unable to resolve Ms. Edmunds' complaint informally, it is required by MCL 169.215(10) to refer the matter to the Attorney General with a request that his office prosecute you for the crime of making a corporate contribution to a candidate committee, a felony violation of MCL 169.254.

CONCILIATION AGREEMENT

Pursuant MCL §169.215(10) of the Michigan Campaign Finance Act (the Act), MCL §169.201 *et seq.*, Susan Woods (Respondent) hereby enters into a conciliation agreement with respect to certain acts, omissions, methods, or practices prohibited by the Act.

The Secretary of State alleges that there may be reason to believe that the Respondent violated MCL §169.254 by using the East Lansing Film Festival website and e-mail list to promote your candidacy, thereby effectuating a corporate contribution to your candidate committee.

Therefore, the Respondent hereby voluntarily enters into this conciliation agreement and assures the Secretary of State that she will comply with the Act and the Rules promulgated to implement the Act.

By executing this conciliation agreement, the Respondent certifies that \$280.00 has been paid as restitution to the East Lansing Film Festival by the Friends of Susan W. Woods candidate committee.

The Secretary of State and the Respondent further agree that this agreement is in effect and enforceable for four years from the date it is signed by the Secretary of State or her duly authorized representative.

The Secretary of State and the Respondent further agree that this agreement, unless violated, shall constitute a complete bar to any further action by the Secretary of State with respect to the alleged violation that resulted in the execution of this agreement.

The Secretary of State and the Respondent further agree that the complaint and investigation that resulted in this agreement are disposed of and will not be the basis for further proceedings, except pursuant to this agreement.

The Secretary of State and the Respondent further agree that this agreement will not prevent the Secretary of State from taking action for violations of this agreement.

The Secretary of State and the Respondent further agree that the Respondent's performance under this agreement shall be given due consideration in any subsequent proceedings.

The Secretary of State and the Respondent further agree that this agreement, when signed, shall become a part of the permanent public records of the Department of State.
