## BUNDLED CONTRIBUTIONS SCHEDULE INSTRUCTIONS

The instructions below are provided to help you: 1.) determine if your committee is required to file this form, 2.) properly complete the form and 3.) properly file the form.

“Bundling Committee” defined: an independent or political committee (PAC) registered with the Secretary of State that makes an expenditure to solicit or collect contributions from individuals that are to be a part of a bundled contribution.

“Bundling” defined: the delivery of 1 or more contributions from individuals to the Candidate Committee of a candidate for Governor, Lt. Governor, Secretary of State, Attorney General, State Board of Education, University of Michigan Regent, Michigan State University Trustee, Wayne State University Governor or Supreme Court Justice, by an Independent or Political Committee (PAC) registered with the Secretary of State.

### First: Determine that the committee is required to file the form:

#### PAC'S

1. You are a committee registered with the Secretary of State; and
2. You have bundled contributions for a candidate for the office of Governor, Lt. Governor, Secretary of State, Attorney General, State Board of Education, University of Michigan Regent, Michigan State University Trustee, Wayne State University Governor or Supreme Court Justice.

NOTE: Contribution limits do apply. Please contact the Bureau of Elections for more information.

#### CANDIDATES

1. You are a candidate for the office of Governor, Lt. Governor, Secretary of State, Attorney General, State Board of Education, University of Michigan Regent, Michigan State University Trustee, Wayne State University Governor or Supreme Court Justice.
2. Received bundled contributions from a PAC that is registered with the Secretary of State.

NOTE: Contribution limits do apply. Please contact the Bureau of Elections for more information.

If you do not meet one of the above sets of requirements, you are not required to file this form.

### Second: Filling out the Form

Items (a) and (b): Check only 1 box (a or b) to indicate the type of committee completing this form.

**Item 1:** Enter the PAC name and Identification number assigned by the Secretary of State.

**Item 2: (Candidate Committee Only)** Enter the Candidate Committee name and Identification number assigned by the Secretary of State.

**Item 3:** Enter the Name of the Candidate, the Office Sought and the Candidate's County of Residence. Note: A separate set of forms must be filed for each candidate that has or will receive bundled contributions. Reproduce blank forms as needed.

**Item 4:** Enter the Name and Street Address of the individual contributor. If the cumulative contribution is over \$100.00, also enter the Occupation, Employer Name and Business Address of the individual contributor.

**Item 5a: (PACs Only)** Enter the date the contribution was received by the Political or Independent committee.

**Item 5b: (PACs Only)** Enter the date the contribution was delivered to the Candidate Committee. Note: Section 44(3) of the Campaign Finance Act states that the contribution must be delivered not later than 10 business days after obtaining possession of the contribution.

**Item 6: (Candidate Committees Only)** Enter the date received by the Candidate Committee.

**Item 7:** Enter the amount of the contribution.

**Item 8:** Enter the page total on each page.

**Item 9:** On the last page of the schedule, enter the total contributions bundled to this Candidate Committee during the current reporting period.

**Item 10:** On the last page of the schedule, enter the cumulative contributions bundled to this Candidate Committee during the election cycle. Number the pages (i.e. 1 of 10, 2 of 10, 3 of 10, etc.)

### Lastly: Copy and File the Forms

**PACs:** Provide 1 copy of this form to the recipient Candidate Committee and File 1 copy of this form with the Secretary of State with the next Campaign Statement filed.

**CANDIDATES:** File 1 copy of this form with the Secretary of State with the next Campaign Statement filed. As an option, you may copy what is provided to you by the bundling committee (PAC) and complete only Items #2 and #6.
