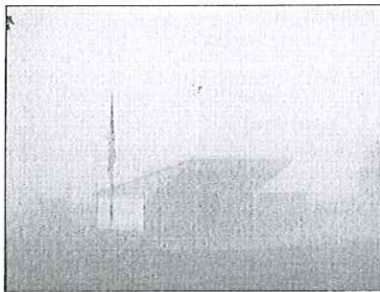

The Land Bank has since sold 37 of those properties, which were worth about \$1,601,997, for \$354,072.03, but did not refund the municipalities.

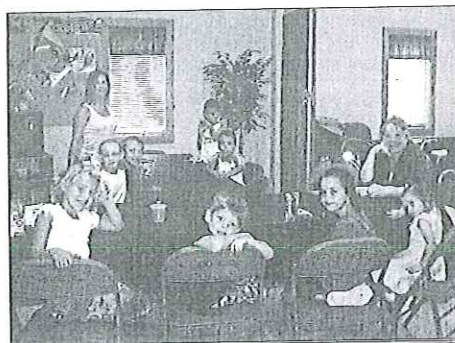

Ancient Israel comes alive in new book

Have you ever wondered what it would be like to actually hear Jesus speak? A new book just published, entitled *Walking in the Dust of Rabbi Jesus*, will make readers feel like they are actual witnesses to Jesus' words through the scholarship of Holland, Michigan author Lois Tverberg.

How is that possible? She begins by leading readers through the core statement of Jewish faith, the *Shema*, to help people deepen their understanding of Jesus' Scriptures and application to modern times.

The third part of the book discusses the discipline of studying the Word with Rabbi Jesus. Since ancient people of Jesus' time knew their Scriptures because they saw study as a form of worship, in this day and age people struggle with how to deal with the inability to know all the answers.

Tverberg points out that Jesus did not preach in an individualistic and materialistic culture like our own, but in a society that deeply valued community.

"If you are walking in your Rabbi's dust, you are called to follow Him into the ashes of our crumbling, burning world," writes Tverberg.

EDITORIAL

David Kolb, the Editorial Page Editor for the Muskegon Chronicle, had an Editorial in the Friday, October 10 paper stating that Chris Beck and Brian Werschm, were both good candidates for Fruitport Township Supervisor but favoring Beck. Evidently, according to Kolb, what Chris had going for him was his "forcefully" arguing for the township's best interest. I, as the outgoing supervisor, had not intended to comment on the two candidates during this election. But being aware of Chris Beck's antics and the negative affect he has had on our township for the last four years, and being aware of his affect on our township the prior four years, I feel that it would be wrong for me to be silent and leave our voters misinformed by Kolb and the Chronicle.

"What's with Chris Beck? Is he running for supervisor already?" was a common question I was asked starting over three years ago. Over time, my answer became I don't know but he sure seems more interested in making a name for himself than what is best for the township.

The Chronicle loves Chris because, on nearly any issue, they can get an opposing viewpoint from him. The Chronicle makes an effort to put some controversy into each article. People are drawn to controversy and Kolb wants the Chronicle's reader to be glued to as many articles as possible. As I have witnessed over the years, Kolb and the Chronicle do not seem to be concerned whether or not the article leaves an accurate impression, but whether it is going to be interesting reading. For eight years, in both the current administration and the previous one, Beck has been happy to oblige.

At the beginning of this administration in the Dunham lawsuit, Chris during his grandstanding made statements that, in my opinion were not true, and according to the township insurance company lawyer, made it difficult to go to trial. Chris was thought of as an unpredictable witness who refused to acknowledge facts he knew to be correct. It cost the township and insurance company each \$50,000 in a settlement. Over the years, his outbursts and contrary attention-seeking actions repeatedly proved to be a detriment of the township, but to the glee of Kolb and the Chronicle because it provided interesting reading. Additionally, once the Chronicle is provided with an interesting story line, even if untrue, they repeat it over and over and get as much mileage out of it as possible. Then later, they repeat the false but still interesting storyline again, sometimes years later. The readers, not having been given an opposing viewpoint, eventually believe what they have been repeatedly reading. Kolb and the Chronicle's job is to truthfully inform the public, but once they print a misrepresented or just plain ignorant story; they become locked into it. Personally, I don't think Kolb is concerned. He seems to form opinions and puts them into editorials with second hand information and very offhandedly fills his editorial space in the Chronicle each day with little concern of what harm it does to people's lives or, in our case, the best management of our township.

Getting back to a few examples of Chris Beck's costly antics:

- The township was in the process of negotiating a settlement with the Magna Corporation, owner of Great Lakes Downs. The lawyers were discussing an amount that Magna would pay to settle of between \$200,000 and \$270,000. Chris evidently found out we were getting close to a settlement, which would have made him look foolish because of his constant criticism of our suits, and proposed to the board that we drop the law suit immediately without even consulting our attorney. He was able to convince a majority of the board to go along with him. It was like throwing \$200,000+ of township money away. It seemed not to concern Chris at all. I called a board meeting with our attorney and he explained that we had just made our offer to accept \$270,000 from Magna and Great Lakes Downs and it was not wise to stop at this time. It did not faze Chris and he continued to press for dropping it.

In my concern that the township not lose this settlement, I offered to pay all attorney and other costs personally if the board would authorize continuing on. Chris still argued against it with the Chronicle gleefully reporting the stupidity of my trying to collect \$1,000,000 owed to the township on one count and \$200,000 - \$300,000 on another. I do not believe that Chris or anyone from the Chronicle have read even 10% of the information necessary to make an informed decision on the validity of our argument that the township is owed these amounts. The board finally overcame Beck's persistence and voted to continue at my personal expense. Of course, after all the one-sided publicity in the Chronicle, Magna and Great Lakes Downs' attorney quickly came back with a \$15,000 counter offer which was coincidentally about what I had to pay for attorney fees to continue the township's lawsuit. Our opportunity was at least temporarily lost.

- The casino issue. After doing considerable research, it became apparent that we were going to get a casino in Fruitport Township. The Little River Band of Ottawa Indians had already paid over five million dollars for Great Lakes Downs and the property south of the racetrack. They were also in negotiations for additional land worth millions of dollars. They were confident that the law would accommodate them. We were in contact with most of the other communities in Michigan that already had casinos and they were telling us what they wished they had done differently and what mistakes they had made. We were becoming very well informed on how to not only protect our township, but to make it the most beneficial to the township.

We knew that the Little River Band of Ottawa Indians had to go through a process of resolutions. They needed a

resolution from the county and the township before they could move on to the state and federal governments. We also knew that we needed to have some developmental agreements with the Indians before or in conjunction with our resolution of support. We knew once they got their resolution of support, our bargaining position was greatly reduced. Our citizens had a lot of questions so it was decided that we would have an informational board meeting to fully inform them of as many of the details as we could of what was transpiring. At that meeting, Chris Beck started hollering and shouting to the crowd about just giving them the resolution without any contingencies. The crowd and other board members responded to his board motion in hysteria.

Jeff Jacobs, Chairman of the Planning Commission, counseled the board that we needed development agreements as contingencies for the resolution of support the Indians needed that would be in the best interest of the township. Chris argued we needed the jobs, etc. and that we need to act now before the Indians changed their minds, as if they or the jobs were going anywhere after just purchasing millions of dollars worth of land. A majority of the board members got caught up in the frenzy and voted to just give them the resolution without any conditions. It was the most significant example of crowd hysteria and stupidity that I ever witnessed in person. It was a terrible decision for our township and its citizens.

During the following two weeks, Fruitport's Planning Commission Chairman, Jeff Jacobs, pleaded with each member individually to add developmental agreement conditions to the resolution of support at the very next board meeting and hoped the Indians would not object. Fortunately, he was successful in doing that and the board added the conditions to their resolution. As it is now, the township did get some of the badly needed protection that was missing from the first resolution, not that it couldn't have been better if we would have taken our time and been more thoughtful.

In the October 10 editorial, the Chronicle still portrays Beck's actions in regard to that incident in a favorable light. Go figure!

Our citizens should also be informed that Chris has gotten upset and walked out of three township board meetings. He also stopped Marjorie Nash and Greg Huika at the township entrance and convinced them to boycott a meeting (Paul Schultz was absent) to prevent a quorum. His reasoning was that he didn't get enough advance information for the meeting. The board meeting, for the most part, was intended to be informational in nature and one inquiry would have informed him if he really wanted to know.

These are a few examples of Chris' attempts to make a political name for himself at the detriment of our community.

Again, in the October 10 Editorial, the Chronicle fails to inform the voters Chris is planning on keeping his full time job and do the township supervisor's job, also. Chris is on the Police Committee and had difficulty making the 4:00 meeting once a month to the point where we changed the meeting to Friday, his day off, so he could make it on time. There are regularly several meetings during the day, besides the evening meetings that often go until 9:00 p.m.; and the phone rings all day with our citizens' needs. I cannot see how he is going to fulfill the needs of our township around another full time job. His offer to reduce his wage by 10% is not going to be a bargain considering he will be on the job part time. During a phone call with a citizen, I often have a call or person with needs, waiting. I doubt that his employer will allow him continuous phone calls during the day, during working hours. It won't work without really short-changing the citizens of our township. The fact that he even thinks it will work makes me wonder if he understands the responsibilities of the township supervisor's job.

Costume class winners were Hailey Buckner in the five to 11 year old competition and Mae LaBrie at the 12 to 19 year old level.

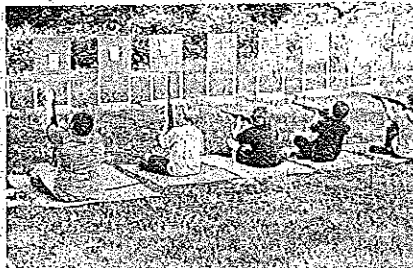

There were many accomplishments during his last term (2004 - 2008):

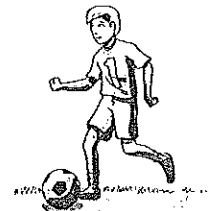
- Converted 5 roads from gravel to asphalt
- Added 11 extensions to our water trunk lines
- Started a soccer park on Sheringer Rd.
- Extended bike paths
- Added to the cemetery building
- Renovating the bathrooms at Farr Field
- Added two practice fields at east side of Farr Field
- Built police headquarters (\$300,000) onto fire station on Airline
- Focused Lights on Water Tower
- Inherited a \$500,000 budget deficit and balanced.
- Left office with a total Fund Balance of \$1,183,738

• **Added 11 needed extensions to our water trunk lines**
Under Ron's administration several important loops were completed that are part of our master plan for water distribution. There are several more that should be completed, but we succeeded in connecting some very important ones that had been ignored for 30 years. A huge contribution to the cost of these improvements and extensions was from grants and contributions from businesses on those lines (over \$600,000). This has added to the circulation and freshness needed for large areas in our township's water system.



• **Eastbound ON & OFF ramps at I-96 and Sternberg Rd.**
This was a high priority project from my first week in office. We went through close to a dozen hearings and received a recommendation from MDOT (Michigan Department of Transportation). The project was sent to the Federal DOT (Department of Transportation) for final approval. Over 2 million dollars [\$2,000,000] in grant money was set aside for this project at the Federal level and more was pledged locally.

• **Land for Soccer Park**
With more than 600 Fruitport Township youth in soccer (more than all the other sports combined), I feel that there is a need for a park dedicated to youth soccer. When I ran for office in 2004, I set as a personal goal to add more soccer fields to our parks system. After taking office, we had meetings with the soccer parents' group and encouraged them to participate and help identify the best location of land the township owned. Forty (40) acres of township property on Porter Road was chosen. Opposition developed against using the land for that purpose, and with the help of some very key people, a 3-way land swap was made with the township, the conservation district, and the school system. The township now has ownership of 20 acres on Sheringer Road for our soccer park.



• Bike Paths

We built miles of bike paths and lanes during both terms, all within our budget. I believe bike paths are important to the health and welfare of our community and much more can be done. When I left office we had about 1/2 of the money needed pledged to connect the Muskatawa bike path on the north to the Spring Lake bike path on the south. It looks like the current administration has aborted the project. Some of the money pledged has now been used for an Ottawa County bike path.
