On April 11, 2017, a federal grand jury indicted State Senator Bert Johnson for allegedly hiring a "ghost employee" that received compensation from the State of Michigan for work she did not perform.

Moved by Pero; supported by Bradshaw. Ayes: Shinkle, Pero, Bradshaw. Nays: None. Motion carried.

Consideration of whether the recall petition submitted by Robert Davis on April 12, 2017 factually and clearly states each reason for the recall of Governor Rick Snyder. The reasons for recall printed in the heading of the petition are as follows:

Governor Rick Snyder is currently under criminal investigation by the FBI for his mishandling of the Flint water crisis.

Board action on agenda item: The Board determined that the above referenced recall petition submitted by Robert Davis on April 12, 2017 does not factually and clearly state each reason for the recall of Governor Rick Snyder because it does not clearly indicate that "his mishandling of the Flint water crisis" occurred during the Governor's current term of office, the word "mishandling" is unclear, and the Board has no knowledge of any investigation by the FBI. Moved by Pero; supported by Bradshaw. Ayes: Shinkle, Pero, Bradshaw. Nays: None. Motion carried.

Consideration of whether the recall petition submitted by Robert Davis on April 12, 2017 factually and clearly states each reason for the recall of Governor Rick Snyder. The reasons for recall printed in the heading of the petition are as follows:

Governor Rick Snyder is currently under criminal investigation by the FBI for allegedly accepting bribes.

Board action on agenda item: The Board determined that the above referenced recall petition submitted by Robert Davis on April 12, 2017 does not factually and clearly state each reason for the recall of Governor Rick Snyder because it does not clearly indicate that he "allegedly accept[ed] bribes" during his current term of office, and the Board has no knowledge of any investigation by the FBI. Moved by Pero; supported by Bradshaw. Ayes: Shinkle, Pero, Bradshaw. Nays: None. Motion carried.

Consideration of a *de minimis* change to the Verity v. 2.2.1 Voting System submitted by Hart InterCivic.
