Agenda item: Consideration of the sufficiency of the recall petition submitted by Sebastian Palamara against Jaime Churches. The reasons for recall stated by the petition are as follows:

On June 20, 2023, State Representative Noah Arbit voted yes on Michigan House Bill 4474.


